A. Project Design

Project Objectives

1) Describe briefly how this project directly responds to the priorities set by APEC Leaders and Ministers and/ or the vision of the host economy. Please make reference to the relevant parts of APEC documents.

This project seeks to first achieve the broader vision of APEC: "stability, security and prosperity for our people". The project is also in line with APEC Viet Nam 2006 theme: "Towards a Dynamic Community for Sustainable Development and Prosperity".

In meeting the above two visions, the project will help raise the capacity for knowledge and innovation, improve access and quality of knowledge resources and bridge the gap between urban and rural communities in terms of employment, poverty and digital divide.

The study particularly responds to APEC's 'Three Pillars' related to Economic and Technical Cooperation (ECOTECH). As stated in APEC website, "ECOTECH is dedicated to providing training and cooperation to build capacities in all APEC member Economies to take advantage of global trade and the New Economy. This area builds capacity at the institutional and personal level to assist APEC Member Economies and its people gain skills to meet their economic potential".

Other related milestones that are referred to include:

- ✓ 2000- Brunei Darussalam: Increase in Internet Access
- √ 2001- People's Republic of China: facilitate infrastructure investment and technology for on-line transactions and promote entrepreneurship and human capacity development

2) Describe the **key objectives** of the project – usually no more than three

The key objectives are to:

- (i) Examine and evaluate existing technological structures in relation to the level of knowledge and skills that exist among the rural poor to acquire further knowledge
- (ii) Collectively design and develop workshop programs that will help build the capacity of community-based organizations to capitalise ODE techniques in their day-to-day operations with rural communities
- (iii) Educate community-based organizations to harness the power of Open and Distance Education (ODE) methodologies which will help increase capacity to achieve greater equity and access to knowledge resources
- 3) Assessment. While the current status will only be clearly known when workshop participants meet and share some base data, the output will include the creation of a set of workshop materials using ODE methodologies based on best practices for increased capacity building. Also a group of trainers and experts will become more knowledgeable in terms of using open distance education techniques.

Short term success will be measured by the sharing of the on-going creation of workshop which will be shared via online technologies.

4) Explain who the intended beneficiaries of this project are.

The primary beneficiaries of the project are the government and NGOs' that work with the rural and poor communities. Their knowledge on how to improve the skills of rural and poor communities on how to acquire and use relevant knowledge will be enhanced.

The secondary beneficiaries will be the rural and poor. They will be more skillful and knowledgeable in how to become independent knowledge seekers, they will use the skills and knowledge to further empower themselves with knowledge, become at ease with the available technologies to gain more knowledge and become active contributors to the economic development of the country.

5) Describe precisely the expected **project outputs**. Describe how these outputs will benefit the targeted beneficiaries.

The project will produce wholesome and quality curriculum materials for capacity building, training materials in different languages and settings to suit cultural, language and gender concerns in the various participating economies, using various ODE techniques.

The materials will be placed on the APEC website for the use of other APEC members.

For this project to succeed, close cooperation and collaboration between the government and non-government sector is very crucial. The non-government sector (which plays an equally important role in rural and poor communities) will be invited to showcase their best practices and share their experiences in planning, designing, developing and implementing similar programmes. The workshop to be held, which will include representatives from APEC member economies will also provide the avenue for feedback and recommendations in this area.

As this project will be geared towards women, the Project Overseer (PO) will ensure women representation will be given priority in the formation of the project team. National/government bodies will be consulted in the respective economies to identify women who have shown some dedication, and grit in poor and rural communities as well as those women active in ICT for the rural and poor and they will be contacted to participate in this important project.

Like other organizations, APEC member economies are concerned about the prosperity of the total population of their economies though the concerns might differ. Due to disparity in the income levels of the populace, the inequitable access to knowledge may lead to unwanted developments in the mental capacities of populace. Thus, it is imperative that this project be carried out in order to capture some of the concerns and tackle them appropriately through concerted dialogue. In view of this, APEC is therefore most appropriate institution to fund the project as it comprises a large number of economies that can benefit from sharing of information and experiences.
