# Background

Drug abuse is a serious and long standing problem that creates tremendous effects on social security and stability of almost every country in the world. Effective suppression was maintained by the Royal Thai Government against drug abusing and drug trafficking during the past decades. The effort to abrogate opium smoking, the most dangerous drug at that time, began in 1955. The first resolution of the Cabinet Assembly in prohibition of opium smoking and selling was issued in 1955. However, the practice of this resolution was prolonged by the objection of Ministry of Finance claiming that the prohibition of opium smoking and selling at that time would cause a great deal of damage to the country.

In 1958, the Government of Revolutionary Party under Field Marshal Sarit Thanarat issued the Proclamation of Revolutionary Party NO. 37 on December 9, 1958, abolishing opium smoking and selling throughout the country. All paraphernalia for opium smoking were incinerated on July 1, 1959 under the supervision of the Field Marshal himself. Since then opium smoking and selling have been declared illegal.

The abrogation of opium smoking and selling had created a new trend of drug abusing and trafficking among countries in Southeast Asia. Other drugs such as morphine and heroin rapidly took place of opium, especially heroin which was easy to consume and easy to avoid detection and suppression. Because of tremendous benefits gained from selling heroin, the dealers had hired foreign experts in producing heroin to come over and set up heroin clandestine labs in Thailand.

Realizing that narcotics problem has become one of the most serious problems that need to be tackled, the Thai Government and other members of the INTERPOL who attended the INTERPOL Meeting on Narcotics Control in Lahor City, Pakistan during January 19-23, 1960, concurred to the recommendation that the narcotics control office should be set up in each country to act as a coordinating body in carrying out drug prevention and suppression activities domestically and internationally.

Responding to the recommendation of the mentioned meeting, the Royal Thai Government had first set up the Central Narcotics Board on April 11, 1961. This Board was chaired by Director-General of Police

Department, and members of the Board were composed of Deputy Permanent Secretaries, Directors and Representatives from various agencies concerned. The Board had set up Thailand Central Bureau of Narcotics, located in the Police Department, to act as a coordinating body in carrying out drug suppression and prevention, and other activities in accordance with commitments made to foreign countries and international organizations.


The Central Narcotics Board also appointed various Sub-Committees in each field, and Regional Sub-Committees to coordinate with the Central Bureau of Narcotics. Moreover, the 7th Sub-Division in Crime Suppression Division was also set up in the Police Department as a special unit being responsible for carrying out drug suppression activities.

Although the Central Narcotics Board had been established in accordance with the resolution of the Cabinet, no legislation was issued to second or to confer the authorities of the Board. Functions of the Board, therefore, automatically terminated whenever there was a change of government. Though the reorganization of the new Board was done in every following government, the Board was still not able to work at its fullest capacity, and was confronted with various problems. As a result, the spreading of drug had a trend to increase dramatically.

Until on November 16, 1976, the present Narcotics Control Board (NCB) was established by the provision of the Narcotics Control Act B.E. 2519 (1976) and the Office of the Narcotics Control Board (ONCB) was also set up to act as a national coordinating body for prevention and suppression of drugs and a secretariat to the Narcotics Control Board under the Office of the Prime Minister.

By virtue of the Administration Organization of State Act (No. 5) B.E.2545 (2002) and the Act on Organization of Ministries, Sub-Ministries, Departments, B.E. 2545 (2002) which entered into force on October 1, 2002, the Office of the Narcotics Control Board has officially been transferred to affiliate to the Ministry of Justice as an independent body directly accountable to the Minister of Justice.

# > By appointment

Six members are appointed by the Cabinet. Up to two of those, who have made outstanding contributions to the fight against drug abuse, shall be recruited from the private sector. The appointed members shall serve for a period of two years, and may be re-appointed.

### **Functions**

- 1. To set up plans and measures on prevention and suppression of drug offenders,
- 2. To supervise the investigation, interrogation and prosecution of narcotics traffickers,
- 3. To plan and implement projects on dissemination of information on the dangers of drug abuse, including to direct governmental agencies concerned to do so.
- 4. To control, expedite, and coordinate drug control efforts of narcotics law enforcement agencies,
- 5. To make recommendations to the Cabinet for the favorable improvement of drug control actions, workplans, or projects of narcotics law enforcement agencies,
- 6. To coordinate and supervise drug dependence treatment programs,
- 7. To approve the appointment of competent officials to perform duties prescribed by the Narcotics Control Act (1976),

- 8. To make recommendations to the Cabinet for the establishment of drug control measures in workplaces. Any business premises are required to be under these measures,
- 9. To perform any tasks prescribed by the Narcotics Control Act B.E. 2519 (1976) as amended by the 4<sup>th</sup> Amendment B.E. 2545 (2002),
- 10. To make recommendation for the appropriate personnel management of public officials who are responsible for good drug control activities or are involved in drug trafficking, including promotion, transfer of position, and disciplinary punishment; and to encourage governmental agencies concerned to actively implement their own management,
- 11. To consider and allocate the drug control budget to both governmental and non-governmental agencies concerned as well as supervise and monitor their expenditure.
- 12. To encourage the governmental and non-governmental agencies as well as the general public to participate in the national drug control efforts.

According to the provisions of the Narcotics Control Act B.E. 2519 (1976) as amended by the 4<sup>th</sup> Amendment B.E. 2545 (2002), NCB may appoint Advisory Committees or Sub-Committees to consider specific matters or take any actions. The following Sub-Committees were set up:

- 1. Sub-Committee on Preventive Drug Education
- 2. Sub-Committee on Treatment and Rehabilitation
- 3. Sub-Committee on Narcotics Law Enforcement
- 4. Sub-Committee on Planning and Budgeting
- 5. Sub-Committee on Monitoring and Evaluation
- 6. Sub-Committee on Drug Seizure Reward
- 7. Sub-Committee on Legal Advisory
- 8. Sub-Committee on International Cooperation

# Office of the Narcotics Control Board (ONCB) Functions

By virtue of the Article 8i of Administration Organization of the State Act B.E. 2534 (1991), as amended by Administration Organization of the State Act (No.4) B.E. 2543 (2000), Minister of Justice has issued the Ministerial Regulation, as announced in the Royal Gazette dated March 10, 2548 (2005), prescribing the functions of the ONCB as follows:

1. To be secretariat and implementing agency of the Narcotics Control Board, Properties Examintion Committee, and be administrative body of any other committee that was appointed by the Cabinet or the Prime Minister to work for narcotics control, as well as be responsible for secretariat work and implementing unit of Advisory Committees and Sub-Committees appointed by the Narcotics Control Board, or Sub-Committees appointed by Properties Examination Committee, or other relevant Sub-Committees appointed,

- 2. To assess national narcotics situation and set up narcotics epidemic surveillance system,
- 3. To recommend, coordinate, and integrate the policy, strategies, plan, and budget in national narcotics control efforts,
  - 4. To administer, encourage, supervise, follow up, and evaluate the national narcotics control efforts, carried out by relevant agencies, in accordance with the policy, strategies, plan, and budget,
  - 5. To recommend and coordinate international cooperation on narcotics control,
  - 6. To be national narcotics control technology center developing and providing technical support on narcotics control to national and international GOs and NGOs,
- 7. To promote and provide support for the development of organization, human resources, information technology, law and regulations concerning narcotics control,
- 8. To carry out anti-narcotics prevention, campaign, and public relations.
  - 9. To be national narcotics intelligence centre,
- 10. To enforce narcotics control laws, including the Acts on Measures for the Suppression of Offender in an Offence Relating to Narcotics B.E. 2534 (1991) and other relevant laws,
- 11. To perform any tasks as prescribed in any laws as being ONCB's authorities or as assigned by the Cabinet or the Minister of Justice.

# Roles and Responsibilities

The roles and responsibilities of the ONCB are as follows:

- 1. To monitor the epidemic of narcotic drugs,
- 2. To develop and review national narcotics control strategy appropriately respond to respective existing narcotics situation,
- 3. To administer narcotics control efforts with integrated approach,

- 4. To supervise, follow up, and evaluate the national narcotics control efforts to be in accordance with the national strategy,
- 5. To administer narcotics law enforcement to be in accordance with narcotics control laws,
- 6. To carry out property examination and seizure measures,
- 7. To be focal point for anti-drugs campaign and public relations,
- 8. To coordinate with international communities and organizations,
- 9. To carry out the development of human resources, information, technical, information technology on narcotics control,
- 10. To promote the strengthening of communities, NGOs, and POs on narcotics control.

The main functions of each part of the ONCB are as follows:

### 1. General Administration Bureau

- To handle the office correspondence and secretarial work,
- To work in compliance with the Office Information Act B.E. 2540 (1997),
- To be in charge of office management including; finance, accounting, budget control, supplies, buildings, vehicles, and office security,
- To be responsible for office personnel management,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 2. Legal Affairs Bureau

- To disseminate information on narcotics control legislation,
- To develop necessary legal measures for the efficiency of narcotics control as well as monitor and assess the implementation on the legal measures,
- To supervise, examine and monitor the investigation, prosecution, and court procedures on significant narcotics cases,
- To control and support the work of competent officers and agencies,
- To carry out litigation support for ONCB or competent officers who perform their duties under narcotics control laws,
- To implement reward money system,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 3. Information Technology Centre

- To support the development of National Narcotics Control Database,
- To prepare and supervise the implementation of the National, Narcotics Control Information Technology and Communication Master Plan,
- To provide services as national narcotics control data centre and support the network links with relevant agencies,
- To design and develop database system and communication links, both internal and interagencies,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 4. Human Resource Development Institute on Narcotics Control

- To develop standard narcotics control training curricular for international and national training courses,
- To develop and implement the national human resource development on narcotics control master plan,
- To conduct core-training courses on narcotics control,
- To coordinate, direct, supervise, and support other agencies to conduct training courses on narcotics control,
- To develop and provide training aids and technology for human resource development on narcotics control to other agencies,
- To act as ASEAN Narcotics Law Enforcement Training Centre,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 5. Narcotics Analysis and Technical Services Institute

- To carry out qualitative and quantitative narcotics analysis in accordance with the Ministerial Regulation on the Arrest, Seize, Analysis of Narcotic Drugs,
- To develop and provide technical support on narcotics analysis to national and international agencies,
- To conduct narcotics identification and impurity study for narcotics surveillance and investigation program,
- To develop a standard operation practice for narcotics analysis as well as supervise and monitor the implementation in compliance with the standard of narcotics analysis,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 6. Narcotics Crop Survey and Monitoring Institute

- To conduct narcotics crop survey, analysis and report,
- To verify, identify and provide information on illicit narcotic crop cultivation to relevant agencies for eradication programme,
- To prepare and support aerial photos, satellite imagery, and GIS data in the current national narcotics situation image map,
- To develop and provide GIS data on narcotics demand and supply,
- To develop technical on narcotics crop survey and monitoring and be centre in gathering and disseminating technical and technology on narcotics crop survey and control at national and international levels,

• To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 7. Foreign Affairs Bureau

- To make recommendations on international narcotics control policy and cooperation,
- To prepare and implement international cooperation on narcotics control,
- To coordinate and promote narcotics control cooperation with foreign countries, international communities and organizations, including the providing and receiving international support,
- To analyze, monitor, and assess international narcotic situation and impact to the implementation on international narcotics control policy,
- To facilitate and coordinate the international drug control efforts,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

### 8. Asset Seizure Bureau

- To confiscate drug offenders' properties in compliance with the Acts on Measures for the Suppression of Offender in an Offence Relating to Narcotics B.E. 2534 (1991), and in accordance with the orders of the Properties Examination Committee and other Sub-Committees appointed by the Committee,
- To be responsible for the secretariat work for the Properties Examination Committee and other Sub-Committees appointed by the Committee,
- To carry out the financial investigation of drug trafficking networks by cooperating with other relevant governmental agencies, domestic, and international financial institutes,
- To supervise, control, and deliberate the examination of seized drug property done by the competent officials who are assigned by the Secretary-General of NCB, or the Properties Examination Committee in compliance with the Acts on Measures for the Suppression of Offender in an Offence Relating to Narcotics B.E. 2534 (1991),
- To manage the Narcotics Control Fund in accordance with the regulations prescribed by the Committee,

• To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

### 9. Narcotics Law Enforcement Bureau

- To make recommendations on national narcotics law enforcement policy, strategies, guidelines, and tactics,
- To administer, coordinate, support, encourage, supervise, monitor, and evaluate the national narcotics law enforcement efforts,
- To act as national narcotics intelligence centre supporting narcotics law enforcement efforts,
- To carry out intelligence and undercover operations in order to investigate the drug trafficking networks in high intensity drug trafficking areas,
- Coordinate with relevant agencies, both at national and international levels, on narcotics law enforcement efforts,
- To develop technical, techniques, and technology on investigation for narcotics law enforcement efforts,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 10. Drug Demand Reduction Bureau

- To make recommendations on drug demand reduction policy, strategies, guidelines, and practices,
- To administer, coordinate, support, encourage, supervise, monitor, and evaluate the national drug demand reduction efforts,
- To develop national narcotics control research and administer Narcotics Control Technology Centre,
- To develop and promote national drug demand reduction measures, guidelines, techniques, and methodologies,
- To develop drug demand reduction campaign plan, produce and disseminate drug demand reduction campaign media as well as provide narcotics control information to respective targets,
- To carry out experimental and specific projects for the development of drug demand reduction measure,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 11. Narcotics Control Strategy Bureau

- To be responsible for the secretarial work of the Narcotics Control Board and other relevant committees,
- To study narcotics control policy, measures, administrative structures as well as the outcomes and other relevant factors,
- To make recommendations on national narcotics control policy, measures, administrative structures,
- To develop national narcotics control master plan, strategic plan, and operational plan,
- To set up the budgetary allocation framework on narcotics control, analyze proposals, and manage the national narcotics control budgetary allocation process and plan,
- To administer, coordinate, and supervise the work of GOs, NGOs, and POs on narcotics control at the national level,
- To follow up, evaluate, and report the results of the implementation of the national narcotics control policy and plan,
- To set up data system for narcotics epidemics surveillance program and for the formulation of national policy and plan, and conduct national narcotics situation report,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 12. Bangkok Area Narcotics Control Office

- To formulate and integrate policy, strategies, plans, and budget program to response to narcotics situation in Bangkok Metropolitan,
- To coordinate and provide technical support to agencies concerned in Bangkok Metropolitan in narcotics control efforts,
- To proceed against illicit drugs traffickers' properties in Bangkok Metropolitan in accordance with the Act on Measures for Suppression of Offenders in an Offence Relating to Narcotics B.E. 2534 (1991) and supervise as well as monitor the enforcement against those traffickers,
- To monitor, assess, and alert narcotics situation in Bangkok Metropolitan,
- To promote the strengthening of communities, NGOs, POs, in their narcotics control efforts in Bangkok Metropolitan,
- To coordinate and provide support to narcotics control program as well as joint operation on narcotics control in Bangkok Metropolitan,

• To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.

# 13 - 21. Narcotics Control Office Region 1-9

- To formulate and integrate policy, strategies, plans, and budget program to response to narcotics situation in their responsible area as prescribed by Minister of Justice,
- To coordinate and provide technical support to agencies concerned in their responsible area in narcotics control efforts,
- To proceed against narcotics traffickers' properties in their responsible area in accordance with the Act on Measures for Suppression of Offenders in an Offence Relating to Narcotics B.E. 2534 (1991) and supervise as well as monitor the enforcement of narcotics laws and regulations,
- To monitor, assess, and alert narcotics situation in their responsible area,
- To promote the strengthening of communities, NGOs, POs, in their narcotics control efforts in their responsible area,
- To coordinate and provide support to narcotics crop eradication program (if any) and the narcotics control implementation as well as joint operation on narcotics control in their responsible area,
- To jointly work with or support narcotics control efforts of other agencies concerned, or to perform any other tasks as assigned.



- Narcotics Control Office Region 4 has jurisdiction over 11 upper Northeastern provinces which are Udon Thani, Nong Bua Lamphu, Nong Khai, Loei, Mukdahan, Sakon Nakhon, Nakhon Phanom, Kalasin, Khon Kaen, Mahasarakam, and Roi Et.
- o Narcotics Control Office Region 5 has jurisdiction over 8 upper North provinces which are Chiang Mai, Lamphun, Lampang, Mae Hong Son, Chiang Rai, Phayao, Phrae, and Nan.
- Narcotics Control Office Region 6 has jurisdiction over 9 lower North provinces which are Phitsanulok, Tak, Phetchabun, Sukhothai, Uttaradit, Nakhon Sawan, Uthai Thani, Kamphaeng Phet, and Phichit.
- Narcotics Control Office Region 7 has jurisdiction over 8 Central and upper South provinces which are Ratchaburi, Suphan Buri, Nakhon Pathom, Kanchanaburi, Phetchaburi, Prachuap Khiri Khan, Samut Songkhram, and Samut Sakhon.
- o Narcotics Control Office Region 8 has jurisdiction over 7 upper South provinces which are Surat Thani, Chumphon, Ranong, Nakhon Si Thammarat, Phuket, Phang-Nga, and Krabi.
- Narcotics Control Office Region 9 has jurisdiction over 7 lower South provinces which are Songkhla, Narathiwat, Satun, Pattani, Yala, Trang, and Phatthalung.
