





Chair of the Greek Host Committee for the 2012 Global Summit of Women, Sofia Economacos is the President of the National and the European Chamber Women Network. She has also been the Secretary General of the Chamber of Tradesmen of Athens, and the Vice-President of the Association of Language School Owners. She is also a member of the European Network of Women in Decision-Making of the European Commission. She has been awarded by the Conseil European Femmes Enterprises et. Commerce and the Chambre de Commerce et d' Industrie de Paris, as the only woman President of a Chamber in Europe.

#### Hon. Yiannis Stournaras, Minister of Development (Greece)

Hon. Yiannis Stournaras is the Minister of Development in the current Greek government. Formerly, he was General Director of the Foundation for Economic and Industrial Research (IOBE), a think tank with the purpose of promoting research on current problems and prospects of the Greek economy and of generating reliable information, analysis and proposals for action. Before joining the IOBE in 2008, he was managing director of Kappa Securities from 2005-2008, and served as Chairman and Chief Executive Officer of Emporiki Bank and Vice-Chairman of the Association of Greek Banks from 2000-2004.

#### H.E. Panagiotis Pikramenos, Prime Minister of Greece

H.E. Panagiotis Pikramenos became Prime Minister of Greece after the legislative election on May 16, 2012. Before being appointed Prime Minister, he served as President of Greece's Council of State, the Supreme Administrative Court of Greece. He began his career as a lawyer in Athens and London until becoming a rapporteur of the Council of State in 1976 before rising steadily until being appointed President in 2009. He also served as General Manager of the National School of Judges from 2005-2009. In addition to his service in the judiciary, he has worked on a number of legislative committees for the Ministry of Justice and from 1991 to 1993 he was a special advisor on judicial affairs to the Prime Minister.

#### H.E. Nguyen Thi Doan, Vice President of Vietnam

Nguyen Thi Doan has served as Vice President of Vietnam since 2007. A Professor and PhD of Economics, Vice President Doan has also served as the Vice-Chairperson of the Inspection Commission of the Communist Party. Prior to that position, she was Rector of the Hanoi Trade University. Vice President Doan is actively engaged in social issues, including enhancing the economic empowerment of women and improving opportunities for disadvantaged groups, including war veterans.

#### Hon. Rodi Kratsa-Tsagaropoulou, Vice President, European Parliament

Rodi Kratsa is a member of the European Parliament from Greece. First elected in 1999, then re-elected in 2004 and in 2009, she was chosen as 1st Vice-President of the European Parliament in January 2007 and re-elected Vice-President in July 2009. Her parliamentary work is rich and multifaceted with a portfolio that ranges from issues of European integration, regional cohesion and economic development, the improvement of women's status and the presence of the EU at international level. Beyond regional concerns, she is active in UNESCO issues concerning education, the promotion of women and cultural heritage



#### Irene Natividad, Summit President, Global Summit of Women (USA)

President of the Global Summit of Women, Irene Natividad also co-chairs Corporate Women Directors International, which promotes the increased participation of women on corporate boards globally. Her commitment to promoting women spans three decades which include leading not only the Summit for 22 years but also chairing the National Commission on Working Women and the National Women's Political Caucus in the US. In 2004, she was selected by *Women's eNews* as one of the "21 Leaders for the 21st Century." Dr. Ana Maria Llopis founded Global Ideas4All S.L. in 2008 and serves as its Chief Executive Officer and Chair. A seasoned corporate director, she is currently on the board of France's Societe Generale, one of the country's largest banks, and is the Chair of the Board of Spain's Dia Hard Discount Stores. She is also a former director on the boards of ABN Amro, Reckitt Benckiser, and British American Tobacco, among others. She founded Openbank in Spain and served as its Chief Executive Officer from 1993 to 2000. She is also a Member of the Good Governance Working Group for Spanish listed companies in the Madrid Stock Exchange.

Maureen Bunyan is a veteran television news broadcaster and a primary anchor for ABC 7, anchoring the 6 p.m. weeknight newscasts. Named a "Washingtonian of the Year" in 1992, Ms. Bunyan is a founder and board member of the International Women's Media Foundation, which serves women in the media in 100 countries. She is also a founder of the National Association of Black Journalists and serves on the National Advisory Board of the Casey Journalism Center on Children & Families, the Girl Scout Council of the Nation's Capital Women's Advisory Board, the Advisory Committee of Women in Film & Video and is a board member of Women of Washington.

#### Henryka Bochniarz, CEO, Boeing Central & Eastern Europe (Poland)

A renowned figure of economic and social life in Poland, Henryka Bochniarz is President of Boeing Central and Eastern Europe as well as President of the Polish Confederation of Private Employers Lewiatan, the largest organisation of private employers in Poland. She is a Member of the Enterprise Policy Group at the European Commission, advising on European economic policy. She was also a Presidential candidate in 2005 and served as Minister of Industry and Trade in 1991. #### Suzan Bayazit, Board Director, TEGV (Turkey)



## Global Summit of Women 2012

### 駐希臘代表處陳代表華玉與我代表團羅團長燦煐拜會希臘性平處 (GSGE,General Secretariat for Gender Equality,Ministry of Interior, Decentralization, and E-Government)秘書長(Secretary General for Gender Equality) Maria Stratigaki 之訪談摘要

#### 一、希臘政府組織

- 1. 希臘政府共有 14 個部會 (ministry),下設祕書處 (General Secretariat) ,一般有 60 個, 目前看守內閣共 40 個。
- 2. 各處祕書長由首相而非部長任命。

#### 二、希臘內政部性平處 (GSGE of Greece)

- 1. 內政部下設三個祕書處。
- 2. 性平處設祕書長一人,下有80人,其中55人為正式公務員,人事費均由政府支應。
- 3. 每年預算平均為 4 百萬歐元,晚近因經濟問題降至 2 百五十萬歐元。
- 4. Maria 原為 Panteiun university 教授, 2009 年 11 月被任命擔任 GSGE 祕書長。

#### 三、GSGE 與婦園學者之関係

- 1. 祕書長為性別研究學者,由首相任命。
- 2、定期諮詢 NGO,以 EU 經費補助 19 個婦團,目前有 20 個方案,8 萬歐元。
- 3、定期諮詢學者,設立五個 scientific committee (無給職),分別處理文化,反暴力、主流化、婦女參政、建制相關史料及審查補助婦團所提計畫等工作。
- 4、性平處網站建立討論平台 (forum),與NGO 保持暢通溝通管道。

#### 四、與歐盟之關係

- 1. 希臘得到歐盟四年(2010-13)6千5百萬歐元經費補助,但只能用於性平方案,不能使用 於政府人事經費。
- 2. 目前已提出七次 CEDAW 報告, 2013 年將提出 2009-13 業務報告。

#### 五、Maria Stratigaki 秘書長之觀點

- 1. 希臘性平發展的轉捩點:希臘在1981加入歐盟,並改由社會黨執政。
- 2. 但 1983 family law 修法則為希臘內部的努力。
