大中華區兩岸四地著作權暨網路犯罪研討會(Greater China Enforcement Symposium)於本(102)年7月9日星期二上午9時至12時30分,假澳門特別行政區澳門路氹連貫公路新濠天地君悅酒店2樓舉行。本次主辦單位爲香港國際影視協會,該協會係美國電影協會(Motion Pictures Association of America)香港地區代表處,邀請臺灣、大陸、香港、澳門等兩岸四地執法單位及相關人士與會參加,會中除報告兩岸四地執行取締違反智慧財產權案件成果外,並期望建立兩岸協處機制,雙方業務主管部門人員進行工作會晤、人員互訪交換相關資料及查緝經驗交流合作,共同打擊跨境侵權犯罪;並建立境外聯繫窗口,建置雙方有關仿冒商標、著作權聯繫窗口機制,建構侵權者之相關資料庫,以縮短聯繫與查緝時程,有效減少侵權犯罪之發生。

# 貳、活動(會議)重點

# 一、活動性質

因網路科技日新月異,盜版侵權活動正利用網路進行違法活動,不斷地掠奪著作權權利人的利益,由於侵權行為不是一個國家或是地區各自存在的問題,而是利用網路在世界不同國家或地區進行犯罪活動。侵權行為人透過網路將侵權物品推廣及銷售到世界各地,利用網路將盜版歌曲、影片及電腦遊戲在網路上肆意上傳、下載,從中獲取不法暴利,損害權利人利益,因此,藉由此研討會之平臺,讓各地執法部門之間持續不斷溝通,進行信息情報互換,不讓侵權行為人逍遙法外。此外,權利人或代表與執法部門保持良好的溝通亦是打擊侵權活動的重要環節,大家齊聚一起共同商議打擊盜版侵權活動的有效策略,並針對各自面對的挑戰與困難,互相參考借鏡其他執法部門所執行的有效法例及措施,以期不斷改善及提昇執法效能。

# 二、活動內容

大中華區兩岸四地著作權暨網路犯罪研討會(Greater China Enforcement Symposium)於本(102)年7月9日星期二上午9時至12時30分,假澳門特別行

政區澳門路氹連貫公路新濠天地君悅酒店 2 樓舉行。本次主辦單位爲香港國際 影視協會,該協會係美國電影協會(Motion Pictures Association of America)香港地 區代表處,邀請臺灣、大陸、香港、澳門等兩岸四地執法單位及相關人士與會 參加,會中除報告兩岸四地執行取締違反智慧財產權案件成果外,另針對互聯 網(Internet)所帶來的衝擊進行探討。

# 三、漕遇之問題

- (一)傳統著作利用型態非常單純,通常係由著作權人從事創作後,自行將著作銷售至著作市場,或將著作授權或讓與給著作推廣或散布者(如:出版社、音樂公司、電影公司等),由這些機構進行著作的重製、加值、行銷等,由著作重製物之銷售獲取商業利益。故傳統著作權人獲取報酬方式,係透過著作重製物的重製、銷售獲取報酬,或是透過授權或讓與給著作推廣、散布者的方式取得報酬。
- (二)然因科技逐漸普及,著作權重製設備興起加速著作物流通,如:公共場所、 餐廳播放音樂、公司行號利用影印機進行重製等;此時著作利用與報酬取得 產生二個問題,第一是著作權人無法向所有著作利用人一一行使權利,因為 著作利用人數量非常龐大,無法逐一查訪著作利用人是否利用著作,縱然可 以證明也無法逐一加以追討,而且此種情形並非透過著作重製物的銷售所能 控制;第二則是部分商業性質的著作利用人(尤其是廣播、電視等),因為所 利用的著作數量過於龐大,牽涉著作權人非常多,與個別著作權人洽談授權 成本可能遠高於取得授權所能獲得之利益,故要求其向個別著作權人取得合 法授權之期待可能性非常小。
- (三)為避免商業性質著作利用人未取得合法授權即行利用著作,將違反著作權法 造成著作權人之損害,以及避免著作權人在法律上的權利,實質上行使有困 難,導致著作權人無法獲取合理報酬,致著作權制度之目的無法達成。因此, 制度上出現新的著作權行使的型態,即是透過著作權集體管理團體(我國稱 著作權仲介團體)來行使著作權人之權利。由著作權集體管理團體取得多數 著作權人授權後,批次(概括)授權給商業性質的著作利用人,並且代替著作

- 權人向未取得授權即行利用之人就著作權侵害所造成的損失追索賠償,以降 低著作交易成本,落實著作權之保護及報酬取得之權利。
- (四)進入網際網路時代(Internet Age)後,除少部分網路上商業性質的利用人仍循傳統管道向著作權人取得合法授權供使用者利用外,網際網路上的著作重製物,多半是來自終端用戶(end user)自著作交易市場取得著作重製物後,在未經著作權人合法授權下,自行將著作重製物數位化,上傳至網際網路與其他使用者進行傳輸、交換的活動,此舉使得多數非商業性質的著作利用人,不再需要透過傳統著作交易市場取得著作重製物,此種著作取得之管道打破傳統以來所建立的著作權市場價值鏈,使著作權人面臨嚴峻的挑戰。
- (五)綜上,當前著作權人及執法部門所面臨的智慧財產侵權案件係來自世界各地,只要有網際網路的地區,只要有使用者取得著作重製物,將其數位化後上傳,著作人即遭受極大的損失。再者,犯罪者(criminals)可能位於國內或國外;使用的電腦(檔案存放位置; file hosting)可能位於國內或國外;使用的電子郵件(email)可能向國內或是國外申請;登記者或註冊者(register or registrar)可能位於國內或國外,因此執法部門跨境的挑戰排列組合如下:

# 四、我方因應方法及效果

- (一)網路科技從傳統式的主從式架構「Client-Server Model」,變成點對點科技「Peer to Peer Network」,再到網路貯存(File-Hosting Sites or Cyberlocker),演變成現在的雲端運算(Cloud Computing),在在顯示科技日新月異。因爲目前雲端運算時代,處理數據量(Data Amount)大、數據多樣性(Data Diversity)多元、數據傳送及處理速度(Data Velocity)快,反倒造成跨境犯罪(Transnational Crime)增加,使執法部門的執法效率(Enforcement Effectiveness)下滑,顯示各國執法部門應針對此問題進行溝通、研商,以有效遏阻跨境犯罪。
- (二)我國執法部門在處理著作權侵權案件中,常發現侵權係源自於大陸地區(境外 IP),然礙於兩岸著作權執法機關之間,並無相關情資交換之機制,致此


類情資無法續行處理,違法侵權者依然逍遙法外。目前處理前述跨境侵權案件,係依經濟部智慧財產局 100 年 11 月 25 日智著字第 10016003900 號函辦理,該函文係轉知 2011 年 8 月間與大陸著作權工作組工作會晤紀錄。其進一步指示,爾後查緝侵害智慧財產權案件如遇網站 IP 位址於大陸地區,陳報相關資料至本總隊轉陳警政署彙整,函請經濟部智慧財產局轉中國大陸國家版權局查處。爰此,在現有海峽兩岸智慧財產權合作保護協議(IPR)第 7 條之協處機制下,建立兩岸著作權執法機關之情資交換機制,以有效遏止兩岸著作權侵權之問題。

# 五、心得及建議

- (一)兩岸執法部門應對目前侵害影音出版及相關文創產品著作權之情形有具體措施,以落實兩岸智慧財產權保護合作協議中對協處機制的具體規定。這是因為兩岸同文同種,使得兩岸間與著作權攸關的影音出版與文創產品得以很容易的被對方的民眾所接受,例如台灣創作之偶像劇、歌曲在大陸受到歡迎。同樣的,大陸創作的連續劇(ex:甄環傳)與選秀節目(ex:我是歌手、好聲音)也受到台灣民眾的喜愛。台灣業者都是以購買版權(取得授權)的方式爲之,但是相對的,許多台灣的文創產品卻在大陸透過網路方式而受到廣泛的侵害。雖說著作權屬於私權,應該由權利人主動爲之,但是由於侵權網站眾多,若要求權利人一一自行爲之,恐力有未逮。
- (二)兩岸 IPR 協議第7條第1項明文規定:雙方同意建立執法協處機制,雙方並同意打擊盜版及仿冒,<u>特別是查處</u>經由網路提供或説明提供盜版圖書、影音(音像)及電腦程式(軟體)等侵權網站,以及在市場流通的盜版及仿冒品。「特別是查處」似意味此等規範乃係對雙方主管機關的規範,而非僅對權利人規範。因此,兩岸間也應對台灣影音出版及相關文創產品之著作權保護問題進一步協商更具體的作法,方能落實兩岸 IPR 協議之執法協處機制的規範。
- (三)定期召開兩岸研討會,透過「海峽兩岸共同打擊犯罪及司法互助協議」、「海 峽兩岸智慧財產權保護合作協議」,建立協處制,雙方業務主管部門人員進行

工作會晤、人員互訪交換相關資料及查緝經驗交流合作,共同打擊跨境侵權 犯罪;並建立境外聯繫窗口,建置雙方有關仿冒商標、著作權聯繫窗口機制, 建構侵權者之相關資料庫,以縮短聯繫與查緝時程,有效減少侵權犯罪之發 生。





NAPP Office organizes and coordinates investigation and handling of cases involving illegal publications and illegal publishing activities, among which, the cases related to copyright infringement account for the majority. For example in 2012, among the total seizure of 450.88 million pieces of illegal publications, there were 363.57 million pieces of pirated publications including 299.23 million pieces of pirated audiovisual products.

II. NAPP and related enforcement agencies are determined to fight against copyright infringement, and have seen dramatic effect. In 2012, by means of intensifying daily supervision and launching special campaigns, NAPP and related enforcement agencies investigated and handled 4.045 cases about copyright infringement, seized 30.85 million pieces of pirated publications (out of 40 million pieces of illegal publications). Comparing with the seizure of 36,36 million pieces of pirated publications in 2011, it indicated that the production and sale of pirated publications had dramatically dropped. We've seen notable purification of cultural environment on the Internet and visible improvement of publication market, With the persistent efforts, 3.59 million pieces of pirated publications were confiscated in Q1 this year, which presented the first sharp decline in the same period of recent years.



全國"掃黃打非"辦公室組織協調查處涉及非法出版物和非法出版活動的案件,絕大多數屬於侵權盜版案件。以2012年為例,全年共收繳各類非法出版物4508.8萬件,其中侵權盜版出版物3635.7萬件,而盜版音像製品就占了2992.3萬件

- 二、"掃黃打非"部門堅決打擊侵權盜版行為,取得重要成效
- 2012年, "掃黃打非"工作以強化日常監管和開展並深化專項行動為主要抓手,堅決打擊侵權盜版等各種非法出版活動,全面開展督查工作,切實加大辦案力度,全年查辦侵權盜版案件4045起,收繳侵權盜版出版物3085萬餘件(非法出版物4000餘萬件)。制售侵權盜版出版物現象明顯減少(2011年為3636萬件),網路文化環境明顯淨化,出版物市場面貌明顯改觀。在持續的高壓態勢下,今年一季度全國收繳侵權盜版出版物359萬件,與往年同期相比,為近年來首次較大幅度下降。





# 壹、前言

為落實保護智慧財產權政策,臺灣多年來經各機關協力執行,在遏止仿冒盜版、教育宣導、邊境管制、加強與國際交流等工作獲得顯著成果。自2009年起,美國已將臺灣從「特別301案」名單中除名;商業軟體聯盟(BSA)的報告亦指出,臺灣軟體盜版率在亞洲地區最低之國家排名第三,僅次於日本與新加坡,並已連續第五年下降,顯示臺灣在落實保護智慧財產權方面,已有卓著進展。














# 一、建立侵權情資交換機制

- 查緝執法人員在處理著作權侵權案件中,常 發現侵權係源自於大陸地區(境外IP),原礙 於兩岸著作權執法機關之間,並無相關情資 交換之機制,致此類情資無法續行處理,違 法侵權者依然逍遙法外。
- 爰此,在現有海峽兩岸智慧財產權合作保護 協議(IPR)第7條之協處機制下,建立兩岸著 作權執法機關之情資交換機制,以有效遏止 兩岸著作權侵權之問題。

# · 具體落實IPR第7條協處機制規定

兩岸同文同種,使得兩岸間與著作權攸關的影音出版與文創產品得以很容易的被對方的民眾所接受,例如台灣創作之偶像劇、歌曲在大陸受到歡迎。同樣的,大陸創作的連續劇(ex:甄環傳)與選秀結目(ex:我是歌手、好聲音)也受到台灣民眾的喜愛。但是區別則在於台灣業者都是以購買版權(取得授權)的方式為之,但是相對的,許多台灣的文創產品卻在大陸透過網路方式而受到廣泛的侵害。

- 雖說著作權屬於私權,應該由權利人主 動為之,但是由於侵權網站眾多,若要 求權利人一一自行為之,力有未逮。
- 兩岸IPR協議第7條第1項明文規定:雙方 同意建立執法協處機制,雙方並同意打 擊盜版及仿冒,特別是查處經由網路提 供或説明提供盜版圖書、影音(音像) 及電腦程式(軟體)等侵權網站,以及 在市場流通的盜版及仿冒品。

• 「特別是查處」似意味此等規範乃係對雙方主管機關的規範,而非僅對權利人規範。因此,兩岸間也應對台灣影音出版及相關文創產品之著作權保護問題進一步協商更具體的作法,方能落實兩岸IPR協議之執法協處機制的規範。



# 关于破获国内首例网络盗版数字高清影视、 游戏和音乐作品案有关情况

# 一、基本案情

2013年4月24日,北京市文化市场行政执法总队会同市公安局海淀分局成功破获国内首例网络盗版数字高清影视、游戏和音乐作品案,抓获周志全、苏立源等犯罪嫌疑人11人。

2013 年初,总队执法人员在检查中发现"思路网" (www.siluhd.com)涉嫌传播盗版高清影视、游戏及音乐作品,该网站自称是"中国数字高清第一门户网站",在业内享有极高知名度。该案盗版侵权作品多、违法情节严重、经营数额高,已达到移送司法机关追究刑事责任标准,2月27日,由总队牵头成立"2·27"专案组,将该案移交海淀公安机关,并会同公安部门进行联合查处。

经查证,"思路网"注册会员达 40 余万人,用户每月缴纳 50 元会费,便可随意下载各种蓝光高清盗版影视、游戏和音乐作品。该网站提供《舌尖上的中国》、《泰囧》、《十二生肖》等国内外知名高清影视剧、音乐专辑、游戏等涉嫌侵权作品 31600 余部,累计下载量达 2000 余万次。其中,中央电视台制作的《舌尖上的中国》累计下载次数达 43 万余次。

"思路网"犯罪团伙主犯周志全,其在北京注册开办心田一品科技有限责任公司,公司有员工 7 人,网站专兼职管理人员达 140 余人,涉及淘宝网店 2 家、网下实体店 2 家。网站内上传者涉及美国、日本等多个国家和地区,每天有上万人在线。该公司通过"网站、论坛、站

点"三级,利用 PT (Private Tracker 私用种子服务器)技术,传播国内外知名数字高清影视剧、游戏、音乐等未经权利人授权的作品,并以网站为载体开办淘宝店销售邀请码和 VIP 充值卡、高清播放机及台式机硬盘等周边外设设备,获取高额利润。

该公司运营基本涵盖了互联网大部分经营模式,网上网下结合,通过广告收入、硬件销售、用户捐赠、会员注册及充值获取巨额收益。此外,网站不仅提供大量侵权盗版作品,还提供淫秽色情和低俗影片,共涉嫌侵权盗版、传播淫秽色情物品和非法经营等3类违法行为。

在全国范围内,执法部门还未曾办理过网络盗版数字高清影视类案件,该案的查处为全国首例,涉及的侵权作品质量高、数量多、传播方式隐蔽。目前该案已被列为 2013 年全国"扫黄打非"工作小组挂牌督办重点案件。

- 4月24日,在总队配合下,海淀分局派出6组干警分别赴嫌疑人的经营场所、居住地和服务器所在地实施抓捕行动,并采取各种技术措施固定网络证据。
- 5月6日,总队将该案移送嫌犯情况向北京市人民检察院第一分院进行抄备。5月12日,经公安部门鉴定,"思路网"提供的《罗马帝国艳情史》、《贝多芬小姐的启蒙》等影片为淫秽色情影片。

目前,该案预审工作仍在进行。

# 二、社会影响

在公安机关和检察机关的密切协作下,在中央电视台等权利人的积极配合下,该案已经取得初步成果。案件的查处沉重打击国内网络盗版侵权行为,产生巨大的社会影响,特别是对国内网络视频行业产生极大震动,对犯罪分子形成强大震慑。

中央电视台新闻频道和法治频道对案件跟踪拍摄,北京新闻频道、法治频道和《京华时报》对抓捕过程进行了拍摄和记录,并于"4.26世界知识产权日"当天分别进行了宣传和报道。案件公布后,产生了强烈的社会反响。4月26日,人民网、百度、新浪、凤凰、搜狐、腾讯、网易等各大门户网站在首页登载案情;相关话题居新浪热门微博榜第一名、热门话题榜第三名,关注、转发人数达4万人以上;百度搜索232万个相关结果,谷歌搜索622万个相关结果;人人影视、中国高清网、CHD 联盟、HDTV 爱好者乐园等多家国内影视分享网站受影响先后关闭;乐视网、百事通等正规企业股价飙升。

5月7日,新闻出版广电总局局长蔡赴朝同志对该案批示肯定;5 月9日,国家版权局专门致信表扬;5月7日至16日,新华网、中国 广播电台、《法制日报》、《中国新闻出版报》等媒体对案件进展进行了 专题报道。案件的查处有效打击犯罪分子嚣张气焰,对社会产生极大 的震慑警示作用,对规范市场秩序、依法保护版权、维护国家文化安 全具有十分重要的意义。
