1. PNG National Food Security Policy 2018 -2025 aligns to the APEC Food Security Road Map 2020

PNG NFSP Goal: Enable all PNGeans to access and consume sufficient, safe, affordable and nutritious food at all times

PNG NFSP focuses on;

- i) Supporting Smallholder Farmers
- ii) Empowering Women in Agriculture (economically empowered)
- iii) Ensure child nutrition (vulnerable members of family & community)

APEC FSRM 2020 Goal: “Attain a food system structure by 2020, sufficient to provide food security to APEC member economies”



2. PNG National E-agriculture Strategy

In aligning to the APEC PNG national theme “*Harnessing Inclusive Opportunities, Embracing the Digital Future*” PNG agriculture sector has recently completed developing the National E-agriculture Strategy in 2017.

Tasks:

- i) Preparing a NEC submission for government endorsement for implementation
- ii) National Department of Agriculture and Livestock has its web page developed for all to access by first week of March 2018

- ii) Piloting the strategy at provincial and regional levels in PNG

Policy Partnership on Food Security (PPFS) Workplan for 2018

Introduction

In 2018, PPFS will continue to further the on-going works aimed at attaining a sustainable APEC Food System as laid out in the APEC Food Security Ministerial and High Level Declarations and the APEC Food Security Roadmap Towards 2020. PPFS will also build momentum on key initiatives, such as the Multi-year Framework on Food Security and Climate Change and the Strategic Framework on Rural-Urban Development to Strengthen Food Security and Quality Growth. Furthermore, in taking heed of the Theme and Priorities of the Papua New Guinea Host Year, PPFS will further explore the role of gender, technology and digital opportunities to drive our efforts to achieving Food Security.

Theme of 2018 FSW and its Objectives

- *Enhancing Food Security through Inclusive Sustainable Growth and Climate-Smart Agriculture and Fisheries*
- Broad objective of the 2018 FSW is to promote and enhance awareness on the value-chain of the food systems, focusing on the sustainable food production, productivity, food and nutrition security, food safety, food loss and wastage, marketing and trade of food products and climate-smart resilience farming systems and fishery.



Specific Objectives of FSW

- For each APEC working group or stakeholder; individually or collectively, make report statements and their progressive work on following thematic area for or by each APEC member economy:
- Increasing food production and its trade by each member economy;
- Reducing the cost of food production at primary level and its value-chain by each member economy;
- Reducing the loss of food by spoilage and wastage along the value-chain;

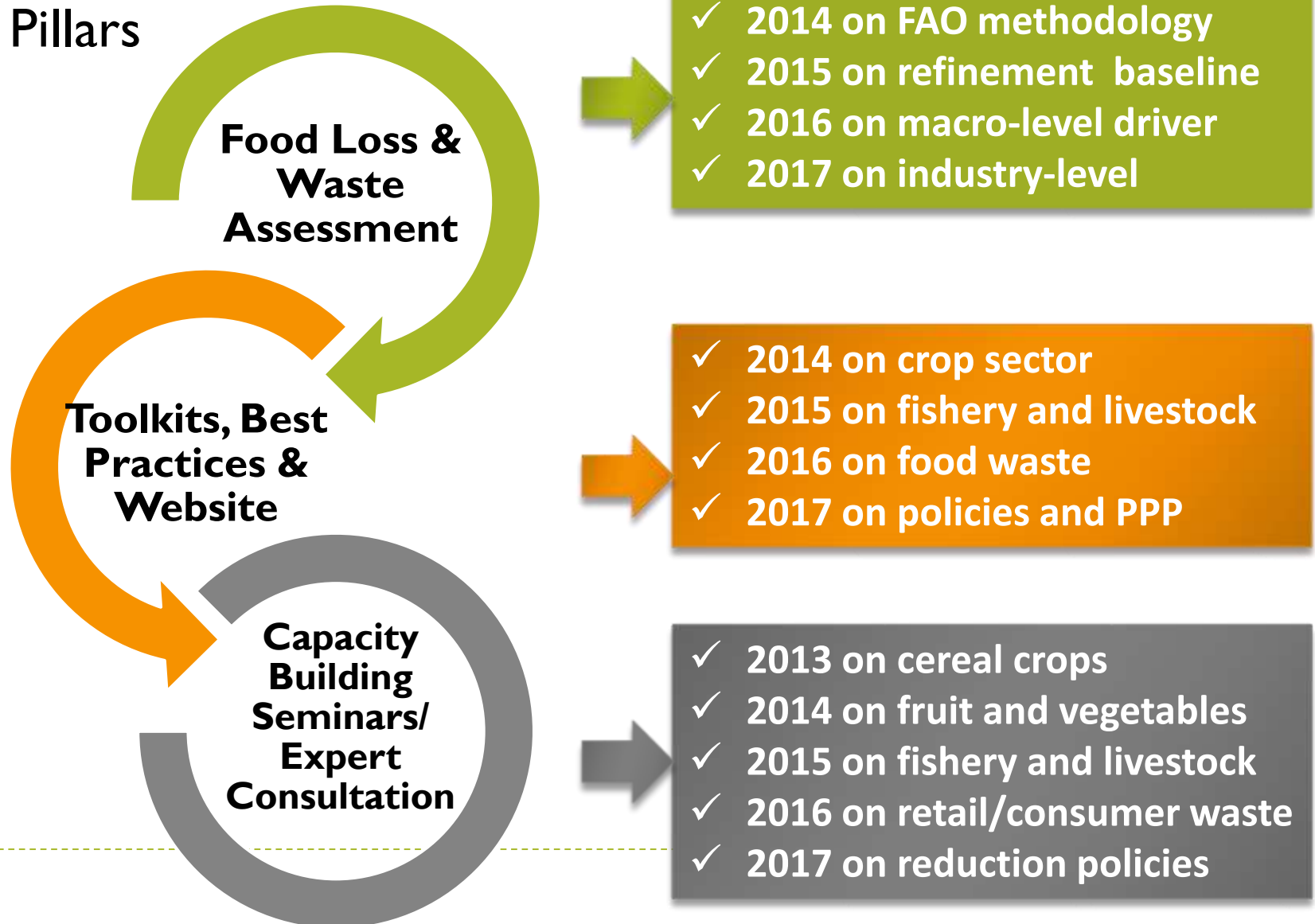

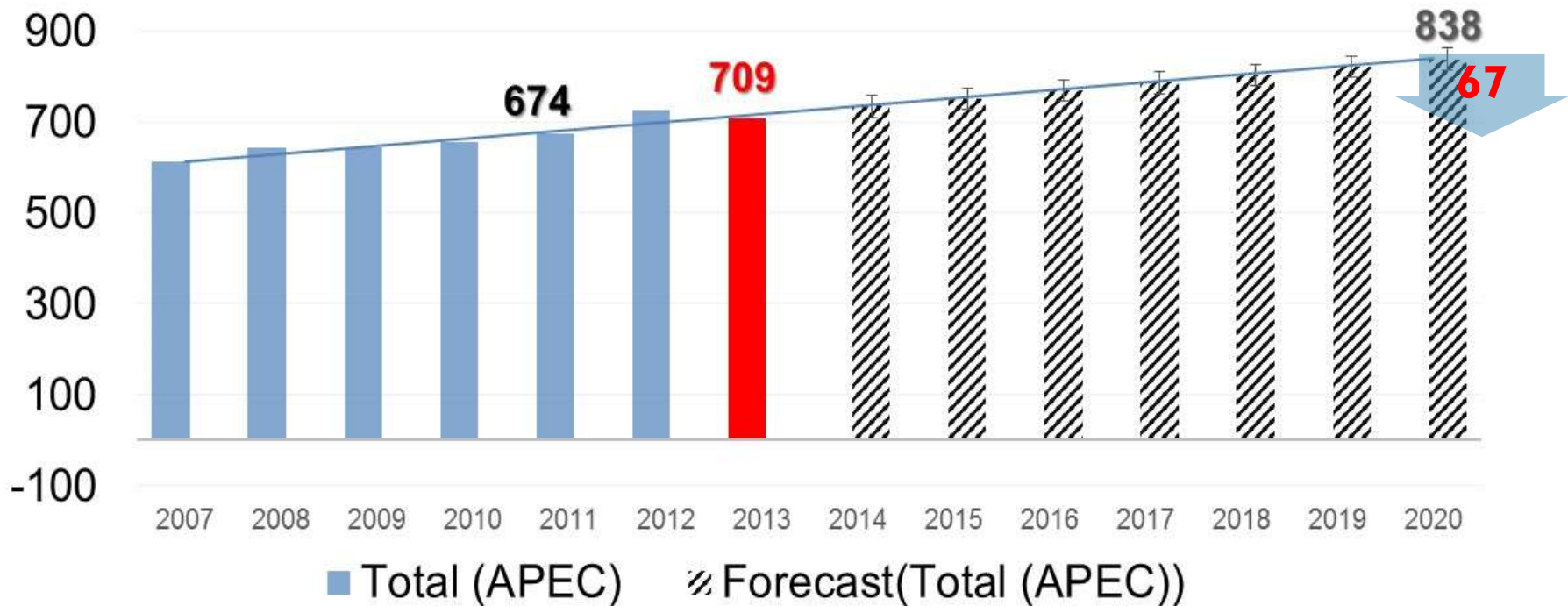

Objectives

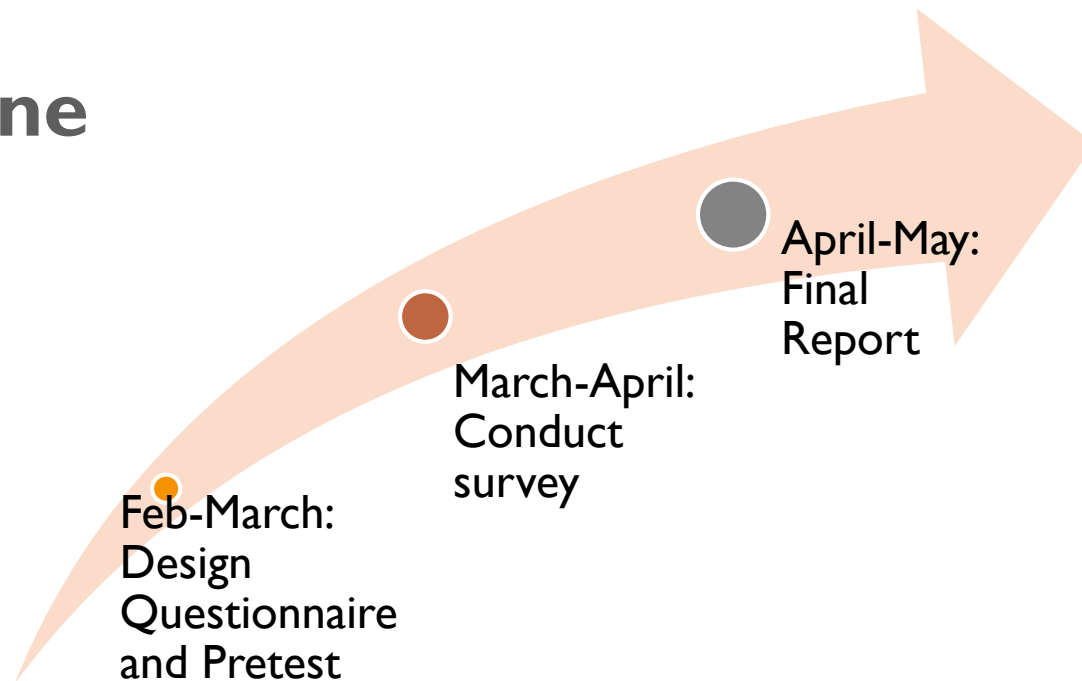

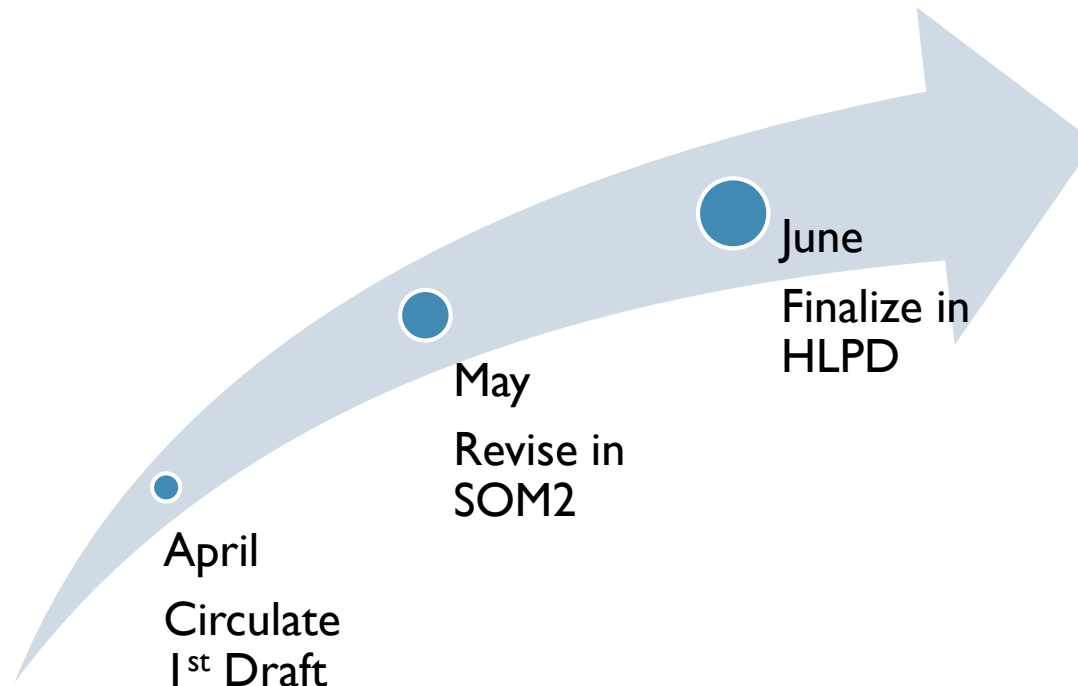
