Hank Intven has practised law, consulted and held policy positions in the areas of telecommunications, broadcasting and the internet. For more than 30 years, Mr. Intven has been recognized as a leading advisor to business, governments and regulators, advising a wide range of communications companies, investors, financial institutions, regulators, governments and other clients on communications-related business, regulatory and policy matters in Canada and in more than 25 countries in Europe, Asia, the Middle East, Africa and Latin America.

Mr Intven served as Executive Director of Telecommunications at the Canadian Radio-television and Telecommunications Commission (CRTC) in the 1980s. He subsequently practised law as a partner of McCarthy Tetrault LLP in Toronto, and led its Communications Practice Group. He was the main external advisor to the Canadian government in the preparation of the Canadian Telecommunications Act. He was also one of three members of the Government of Canada's Telecommunications Policy Review Panel, which delivered a blueprint for the future of Canadian telecommunications policy in March 2006. He currently serves as a member of the Government of Canada's Broadcasting and Telecommunications Legislative Review Panel, which was established on June 5, 2018 and is due to report in January, 2020.

Mr. Intven is the author of the Canadian Telecommunications Regulatory Handbook, a comprehensive guide to Canadian telecommunications law and regulation, published in 2012, 2014, 2016 & 2017. He is also the editor of the international Telecommunications Regulation Handbook, published in 2000 and distributed around the world by The World Bank and the ITU in English, Spanish, French, Chinese, Russian and Arabic.

原住民電視網(APTN)執行長 [Jean La Rose](#)

Jean La Rose is a First Nations citizen from the Abenakis First Nation of Odanak in Québec. He was raised in Ottawa where he studied Journalism at Algonquin College and obtained his Bachelor of Arts in Social Communication at the University of Ottawa/Université St. Paul.

Since November 2002 Jean La Rose has been the Chief Executive Officer of APTN, the first national Indigenous broadcaster in the world, with

programming by, for and about Indigenous Peoples. Since joining the network he has established it on a strong financial position for long-term growth. Mr. La Rose moved the network to a full high-definition platform, and now employs more than 150 people nationwide and provides production opportunities for over 100 Indigenous producers in Canada. He established APTN service in eastern, western and northern communities, became a founding member of the new World Indigenous Television Broadcasters Network (WITBN), and as partner of 2010 Olympics led the first ever broadcast in eight different Indigenous languages, 14 hours per day.

Preparing APTN for future growth, he has developed the organization into an IP-based, multi-platform broadcaster. He has also overseen the purchase of the buildings APTN occupies in Winnipeg and the renovation of one to house the new state-of-the-art news studio. Moreover, two regional studios have been established as well as home offices for video journalists to broaden the network's news reporting capabilities across the country.

Member of the Quebec Bar since 1985 and holder of a

Stephen has been active in lobbying for reform of Canada's copyright laws, and has participated as a director, committee member or founder

of a number of cultural industry associations. He has appeared on numerous occasions as an expert witness before the Copyright Board of Canada.

He is currently Chair of Orange Lounge Recordings; a Director of ISAN Canada, the Canadian Retransmission Collective, and the Producers Audiovisual Collective of Canada; and a member of the Society of Composers, Authors and Publishers Association of Canada (SOCAN).
