# 「美國航電技工班」 完訓返國報告

# 摘要

本次受訓班隊為航電技工班,受訓地點為美國陸軍運輸後勤訓練基地,位於 美國東部維吉尼亞州的尤斯帝斯堡。課程內容為 CH-47F、UH-60A/L、UH-60M 此三 種直升機機型,其航電儀表系統相關功能介紹、技令書刊使用、各項組件操作檢 查、測試裝備介紹及實作使用、系統故障排除方式的說明與實作。全部課程共計為 期 25 週的訓練,於訓練課程中,指導教官著重強調技令的重要性,並且無論是學 科介紹導讀,亦或是術科實作,均依技令規範實施。透過後勤戰力的培養,達到提 升建軍備戰、戰備整備之效能。

# 壹、目的

為提升航電修護技能,此航電技工班受訓地點為美國陸軍運輸後勤訓練基地 Fort Eustis,此課程目的為指導學員熟悉 CH-47F、UH-60A/L、UH-60M 此三種直升 機機型之航電系統修護技術,了解其系統相互關係,各重要組件功能,能使用技令 書刊及三用電表量測線路,並加以故障排除,使直升機維持功能正常,以達建軍備 戰之效能。

# 貳、過程

本班隊訓練期程共計 25 週,各週課程分述如次:

### 第一调:

以簡報告知學員,了解學校對學生的各項要求及規定,帶領學生辦理身份 ID 卡,申請美國銀行帳戶,及到醫療中心建立學生身份檔案,簡介上課環境跟生活設施,並實施落地考 ECL 測驗。

# 第二週:

針對各種國內外可能面臨的作戰環境,及對部隊可能造成影響的安全議題進行研討, 技令航保手冊 DA PAM 738-751 介紹手冊內容,如何使用在飛機維保表格,具體使 用時機,相關人員核准權責及方式,及航保手冊實作測考。

# 第三週:

講解航空保修技令 TM1-1500-204-23-1 如何查詢使用, Aviation Unit Maintenance (AVUM)和 Aviation Intermediate Maintenance (AVIM)在保修層級上的權責差異,各式保修工具功能講解說明,使用時機及方式,精密量測工具其送校時機及規定,及術科保險實作。

## 第四週:

講解基本電學—直流電原理,電壓,電流及電阻之間的相互關係,三用電表的使用 方式。搭地的效果,基本電學安全規定,介定基本電學的術語,各種單位說明,及 各式符號講解。

# 第五週:

講解基本電學一交流電原理,感應線圈,變壓器,二極體,整流器,電晶體作用原

理。導體,半導體,及絕緣體的差異性,靜電效應產生及防護。說明抵抗電流如何改變 感應線圈。說明電壓,電流及電阻計算公式。

### 第六週:

本週課程為戰場線束修護,依技令規範,教官教導學生使用正確的制式工具,線束相關綑綁限制,長度及其鬆緊度控制,如何正確且快速修復破損線束,教導學生如何使用工具壓接端子實作練習,並實施測考。

# 第七週:

本週課程為戰場線束修護,依技令規範,教官教導學生焊接工具使用方法,使用焊接工具注意事項,教官指導學生如何使用焊接工具修復機內通話開關和線束,進行 實作練習,並實施測考。

# 第八週:

UH-60A/L電子技令IETM 導讀,各章節代表意義,飛機功能章節說明,飛機故障排除章節說明,飛機各組件保修,組件拆除步驟,組件安裝程序,說明保修權責區分MAC表中的標準人工時,修護來源代碼講解。

# 第九週:

ULLS-A(E)美軍保修系統使用介紹,SS1-6各式電子表格說明操作方式及如何填寫,各欄位代碼代表意義,進行實作練習,並實施測考。地面動力裝備 AGPU 使用介紹,操作限制,注意事項,對學生實施實作練習,並實施測考。

# 第十週:

CH-47F、UH-60A/L、UH-60M 此三種直升機機型的改良式資料數據機 Improved Data Modem (IDM),多功能顯示器 Multi-Funtion Display (MFD),控制顯示單元 Control Display Unit (CDU)系統說明介紹,操作檢查,故障排除,及實作測考。

# 第十一週:

CH-47F、UH-60A/L、UH-60M 此三種直升機機型的資料傳輸模組 Data Transfer Set (DTS),機內通話系統 Inter Communication System (ICS)系統說明介紹,操作檢查,故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

# 第十二週;

機內通話系統 Inter Communication System (ICS)中的單頻地空無線電系統 SINCGARS, 超高頻無線電 VHF(AN/ARC-210D)說明介紹,操作檢查,故障排除,使用電子技令 查詢,注意事項,對學生實施實作練習,並實施測考。

# 第十三週:

機內通話系統 Inter Communication System (ICS)中的極高頻無線電 UHF(AN/ARC-164), 多頻段無線電系統(AN/ARC-231)說明介紹,操作檢查,故障排除,使用電子技令查 詢,注意事項,對學生實施實作練習,並實施測考。

### 第十四调:

機內通話系統 Inter Communication System (ICS)中的高頻無線電 HF(AN/ARC-220),大 氣資料電腦 Air Data Computer (ADC)說明介紹,操作檢查,故障排除,使用電子技 令查詢,注意事項,對學生實施實作練習,並實施測考。

### 第十五週:

CH-47F、UH-60A/L、UH-60M 此三種直升機機型的自動飛行控制系統 Auto Flight Control System (AFCS)說明,相關組件介紹,操作檢查,故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

## 第十六週:

水平安定舵 Stabilator Unit 說明介紹,操作檢查,教官指導學生如何使用測試裝備進行故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

# 第十七週:

雙水平安定舵控制器 Dual Stabilator Controller 說明介紹,操作檢查,教官指導學生如何使用測試裝備進行故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

# 第十八週:

指揮儀器組件 Command Instrument Set 說明介紹,操作檢查,故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

# 第十九週:

飛行導航導向 Flight Director,大氣資料電腦組件 Air Data Computer Set 各組件說明介紹,相關系統操作檢查,故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

## 第二十週:

自動尋標儀 Auto Direction Finder LF/ADF(AN/ARN149V), 民用導航 Civil Navigation(AN/ARN147V), 雷達高度表 Radar Altimeter, 戰術空中導航 TACAN 各組件說明介紹,相關系統操作檢查,故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

# 第二十一週:

內嵌式全球定位系統及慣性導航 EGI,天氣觀測器 Storm Scope(WX-500),電子式備用儀器系統 Electronic Standby Instrument System (ESIS)各組件說明介紹,相關系統操作檢查,故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

## 第二十二週:

抬頭顯示器 Head-Up Display (HUD)功能說明介紹,操作檢查,故障排除,使用電子 技令查詢,注意事項,對學生實施實作練習,並實施測考。

第二十三週及第二十四週:

學校停課。

# 第二十五週:

訊號資料轉換器 Signal Data Converter (SDC), 陀螺磁羅盤 Gtyo Magnetic Compass GMS(AN/ASN-43)說明介紹,操作檢查,故障排除,使用電子技令查詢,注意事項,對學生實施實作練習,並實施測考。

# 參、心得

美軍在基本班隊要求十分紮實,前兩個月的課堂訓練內容雖然很無趣,幾乎都是基本原理講解,連教官也自我解嘲說,這根本就是在上大學的電學課程,但是他也沒有因此就跳過,或是簡化任何步驟,務求學生都能理解內容。在考試時,強調各位學生要有榮譽心,可以考不及格再補考,但絕不允許任何做弊行為。並且嚴格執行監考督考,而且也未曾聽聞有學生做弊情事。

在後續的各機型航電系統介紹中,教官也很風趣的分享他在阿富汗經歷過的 一些趣事,讓課堂上充滿笑聲,不同的視野,也增進了我對國際情勢的了解。

在訓練課程中,個人最為欣羨的就是美軍的後勤資源豐富,不僅有足量足夠的保修工具,設備,線材,耗材等等可供練習使用,每位學生都能使用模擬機來實習機上保修,故障排除,及功能測試。確保學生在派任到單位前,就能具備基本程度的保修執行能力。可以說只要給他一本技令,他就能上場執行飛機修護任務了。

另外發現美國陸軍就算在受訓時,也分成三班制進行,有日班,夜班,及大 夜班,一方面使學員在受訓時,就已經開始逐步適應戰場所需,另一方面也是讓現 有硬體設施處於極佳的週轉,可說是達到為戰而訓的精神。

# 肆、建議



  c. The DMS and dependents listed are required to acquire and maintain healthcare insurance coverage through the duration of their training in the United States. The IMS mill be responsible for custodial fees and personal debts incurred by self or family members. This includes accepting responsibility for reimbursing the providers of all emergency/ non-elective medical costs for the IMS and all authorized dependents during their stay in the United States. If the IMS permits his healthcare policy to lapse, is unable to meet these financial obligations and the home country government has not agreed to indemnify the costs, the DMS may be withdrawn from training and returned to home country. This will jopandize future grant funding and training allocations for the country. Despite the lack of an indemnification letter from the foreign government, the IMS government will still be expected to pay for all medical costs to reat an IMS and/or authorized dependents for any pre-existing condition, including, pregnancy coverage, high blood pressure and dialysis.
