一、案由:

我國於本(111)年8月20日至24日派員赴泰國清邁出席2022年亞太經濟合作(APEC)第3次資深官員會議(SOM3)期間「商務人士移動小組」(Business Mobility Group, BMG)會議及「安全旅運任務小組」(Safe Passage Taskforce, SPTF)專案會議,相關參與過程及各該會議要情與決議以「雙邊諮商過程」、「參與商務人士移動小組(BMG)全體會議情形」、「參與安全旅運任務小組(SPTF)專案會議情形」、「各會員體之間及與APEC 秘書處互動交流情形」及「相關議題後續待辦事項」分述如後。

二、雙邊諮商過程:

本案「商務人士移動小組」(BMG)常設召集方澳洲邀請其他會員體於本年 8 月 20 日分別進行雙邊諮商。我方由外交部領事事務局蕭一等秘書輔鼓、柯書記佩廷及內政部移民署國境事務大隊傅隊長水添與現任 BMG 召集人澳洲內政部(Department of Home Affairs)官員 Matthew Bannon 及預定明年接任之 Sally McLean 進行對談,要點如次:

(一) 改正 APEC 官網網頁有關 ABTC(APEC Business Travel Card)虛擬卡之中文宣導資料事:

我方注及 APEC 官網網頁有關 ABTC 虛擬卡之中文宣導資料僅提供簡體字版本,建議澳方增設「正體中文」版本。澳方同意即著手撰擬正體中文版。

(二)部分會員體審核 ABTC 申請案有延宕情形:

我方關切俄羅斯、巴布亞紐幾內亞及越南對 ABTC 申請案之審核多有整 批次延宕情形,請召集方敦促改善,以維申請人權益及 ABTC 公信力。澳方 表示已注及該情,且迭次提醒各該會員體,已納入此次全體會議議程,建議 我方與會發言提敘,供列入會議紀錄,從而提醒各該會員體設法改善。

(三)美國倡議修改 BMG 組織章程(BMG Terms of Reference),改變由澳洲擔任單一常任召集方之現狀事:

BMG 係 APEC 目前唯一採單一常任召集方機制之次級論壇,貿易暨投資委員會(CTI)要求,至遲須於 2025 年前決議改制。

三、參與商務人士移動小組(BMG)全體會議情形:

本年8月21日至22日召開BMG全體會議,要情扼陳如次:

(一) ABTC 計畫辦理情形報告與資訊安全管理機制:

- 1、我方發言說明對 ABTC 申請案之核處未受 COVID-19 疫情影響,自始維持正常受理、審查與發卡作業,自 2002 年至 2022 年 7 月底我方累計發卡 36,576 件及審核 716,235 件。另自本年 3 月 7 日放寬含 ABTC 持卡人在內之商務人士來臺,得於備妥相關商務證明、經國境查驗無慮後入境。
- 2、部分會員體審核 ABTC 申請案多有整批次延宕情形,我方提醒宜積極加速處理,以維申請人權益及 ABTC 公信力。
- 3、我方依循政府資通訊安全指導原則與政策方案以及個人資料保護法等相關 法規辦理 ABTC 系統之資訊安全管理。
- 4、澳方提案更新 ABTC 系統操作指南業經初步檢審核校,請各會員體續提出反 饋意見。
- 5、澳方提報「ABTC 計畫執行成效檢視研析報告」案概念文件,將就 ABTC 計畫 與執行情形進行整體性成果檢視及分析。

(二)恢復與促進 COVID-19 疫後區域內跨境移動:

APEC 將參考 ABTC 計畫之成功模式,設法恢復 COVID-19 疫後區域內跨境移動,建議會員體考量數位資訊交換及提升 ABTC 虛擬卡應用程式效能。

(三)美國倡議修改 BMG 組織章程,由目前澳洲擔任單一常任召集方,改為會員體 間以共識決推選非常任召集方,任期 2 年:

本案列出二備選方案待議,其中甲案僅選出單一召集方,乙案則推選正、副召集方。主席要求各會員體於9月底前提出意見,以利於11月前彙報CTI。

四、參與安全旅運任務小組(SPTF)專案會議情形:

SPTF 專案會議於 8 月 24 日舉行。我方由蕭員 3 人續留清邁出席,另衛生福利部原定指派王分析師崇道赴泰,惟行前檢測 COVID-19 呈陽性,改以視訊方式參加。會議要情如次:

- (一)邀請 APEC 企業諮詢委員會(ABAC)、世界衛生組織(WHO)、經濟合作暨發展組織(OECD)說明全球安全旅運相關倡議之進展。另由政策支援小組(PSU)提報「COVID-19 疫情與 APEC 區域內跨境移動:邊境線上不確定性之處理」研究報告案。
- (二)各會員體報告相關提案工作進程,BMG、觀光工作小組(TWG)、運輸工作小組 (TPTWG)、衛生工作小組(HWG)分享各工作小組內部討論情形,並承諾上揭各 提案將在各工作小組繼續推進。
- (三) SPTF 將於本年 11 月落日終止,將向 SOM 提報原則性成果,包括同意 PSU 專題研究報告結論及落實安全旅運之相互操作性原則,未來轉由 SOM「人員間連結性(People to People Connectivity)主席之友(Friends of the Chair, FotC)」進行跨領域協調,以推進相關工作。此方向獲各會員體表態支持。

五、各會員體之間及與 APEC 秘書處互動交流情形:

- (一) 我方團隊全員應邀參加泰國外交部領務司副司長 Narong Boonsatheanwong 舉行之歡迎酒會,與泰國、澳洲、美國、韓國各會員體 BMG 團隊成員、APEC 秘書處及 PSU 人員交際聯誼並建立聯繫管道,以爭取國際友誼並為日後業務溝通之用。
- (二) 地主國泰國及 BMG 召集方澳洲對於我方派員赴泰出席實體會議多次表達感謝,讚揚我方對 APEC 事務之積極參與和支持。
- (三)中國大陸地區由外交部官員 Shuangqing Cheng 以視訊方式參加 BMG 會議, 另 SPTF 亦採線上與會。
- (四)為推廣就業金卡,我方於場邊非正式會談方式向與會代表宣傳就業金卡。

(五)為培訓我方人員專業職能及加強參與 APEC 事務,本案赴泰與會蕭員 3 人於 8 月 23 日參加 APEC 秘書處計畫管理單位(Project Management Unit, PMU) 舉辦「計畫品質訓練(Project Quality Training)」研訓活動。

六、相關議題後續待辦事項:

- (一) 我方將與澳洲合作建置 APEC 網站 CTI 之 BMG 項下 ABTC 虛擬卡宣導網頁之「常見問題集」(FAQ)及「快速使用者指南」(Quick Reference User Guide) 資訊正體中文版,並注意更正簡體中文版名稱情形。
- (二)持續配合澳方所提案更新之「亞太經濟商務合作旅行卡」(ABTC)系統操作指 南之檢審工作,並提出反饋意見。
- (三)核校澳方提報「ABTC計畫執行成效檢視研析報告」關於我方資訊之正確性, 並參考整體報告內容,檢審我方工作可再予精進之處。
- (四)賡續密注美國倡議「修改 BMG 組織章程」及泰國倡議「ABTC 包容性聲明」兩案進展。
- (五)關於 PSU「COVID-19 疫情與 APEC 區域內跨境移動:邊境線上不確定性之處理」專題研究報告,已於本年 8 月 31 日以外授領二字第 1116800923 號函請衛福部及移民署協助檢視內容,並提供與我方相關部分之更新資料,嗣獲電郵回覆原則性意見,爰權以我國現行邊境管制與防檢疫措施資訊及相關網路連結,建議 PSU 憑以更新資訊修撰報告內容。嗣經檢視該專題報告最終版本,我方資料多已獲更新至本年 9 月 20 日。
- (六)查 SPTF 係為設法解決 COVID-19 疫情期間 APEC 區域內各會員體間人員跨境安全旅行移動之議題而成立,我方經外交部國組司會請領事事務局擔任聯繫窗口。鑒於其業務涉及 HWG、TPTWG、BMG、TWG、數位經濟指導小組(DESG)、服務業小組(GOS)等,爰實務運作上係邀請我國各相關主政單位衛生福利部國際合作組、交通部運輸研究所、交通部觀光局、國家發展委員會、經濟部國際貿易局共同組成,分就各機關業務職掌交換各工作小組推動情形之相

關情資,並據以彙綜我方對安全旅運基本立場,且組團共同參與會議說明我方立場及作為。SPTF歷經 2022 年 SOM 期間召開 3 次會議,將於本年 11 月落日終止,相關議題將轉由 SOM「人員間連結性(People to People Connectivity)主席之友(Friends of the Chair, FotC)」進行協調,回歸由各工作小組繼續推動,爰建議亦解散我方 SPTF 任務小組,相關議題回歸由 SOM 窗口本部國組司總承或由相關議題之各工作小組主政單位分別負責。




