Membership

- 63 Member States
 - Ukraine moved from Corresponding Member to Member State in April 2021
 - Ethiopia rejoined as a Member State in May 2022
- 64 Corresponding Members
 - Saint Lucia joined as a Corresponding Member in October 2022
- Campaign to encourage members to pay on time (at the beginning of the year) and not to fall behind in payments – will be struck off if three year of arrears

New projects approved at the 57th CIML Meeting, 18-20 October 2022

- Revision of B 6:2019 *Directives for OIML technical work*
 - Part 1: *Structures and procedures for the development of OIML publications*
 - Part 2: *Guide to the drafting and presentation of OIML publications*
- Revision of D 11:2013 *General requirements for measuring instruments – Environmental conditions*
- Revision of R 75:2002 *Heat meters*
- Revision of R 137:2012 *Gas meters*





OIML Certification System (OIML-CS)

- Continues to operate well despite the pandemic
- Revision of B 18:2018 *Framework for the OIML Certification System (OIML-CS)* approved
 - implements CIML decision to allow OIML Issuing Authorities to use ISO/IEC 17020 (with additional requirements) as an alternative to ISO/IEC 17065 to demonstrate competence





Countries and Economies with Emerging Metrology Systems (CEEMS)

- Collaboration with the BIPM to develop e-Learning package and other materials on D 1 *National metrology systems – Developing the institutional and legislative framework*
- Training event on prepackages being planned for July 2023 in Germany
- Restarting of CEEMS/p 1 project on the revision of D 14 *Training and qualification of legal metrology personnel*





Digitalisation Task Group (OIML DTG)

- Support of the IMEKO TC6 Conference *Metrology and digital transformation* in September 2022
- Support for OIML technical work regarding “SMART”
- Strategic items on the OIML’s role in an international digital metrology system
- Support for CEEMS AG *Online technology* project





OIML technical work

- *Electric vehicle charging stations* – TC 12/p 3
 - G 22 just published
 - Project Group now continuing to produce full Recommendation
- *Medical measuring instruments* – TC 18/SC 1 and TC 18/SC 2
 - Six new projects approved in 2021
 - Only a few countries registered for work on two projects on blood pressure instruments – please consider joining



Reminder of decisions on Membership fees taken at 16th OIML Conference in 2021



- New budget for the financial period 2022-2025
- New scheme for restructuring OIML Corresponding Member fees, to bring them into line with the criteria used for OIML Member States
 - Will be classified by population and GNI
 - New structure will be phased in
- Fees were reduced in 2012 and unchanged between 2013-2021
- In new budget, fees will increase by 1.4 % / year from 2022–2025





Membership classes

- Four classes according to population:
 - Class 1: ≤ 10 million
 - Class 2: > 10 million to ≤ 40 million
 - Class 3: > 40 million to ≤ 100 million
 - Class 4: > 100 million
- Class reductions possible according to GNI/capita
- Has always been used for Member States
- Will be used for Corresponding Members from 2023





Corresponding Member fees

- Possibilities for Corresponding Member participation in OIML work have significantly increased since 1955
- Previous situation:
 - Fixed annual fee, regardless of population and participation
 - 10 % of Class 1 Member State fee (€1 420 in 2022)
- In 2023, will pay fees based on the four classes
- Over the period 2024–2028, fees will increase progressively to become 50 % of equivalent Member State fee by 2028
