# 9. Business meeting to address other ongoing RLMO and relevant OIML matters

- e. Has there been any change in the view about making relationship between RLMOs and OIML more formal?;
  - No. The RLMOs prefer to keep the current arrangement, where the RLMOs are entirely independent of OIML on a formal basis but continue to interact with OIML through the Round Table. Also, the RLMOs benefit from participation of OIML-CS representatives in some RLMO meetings. Some of the RLMOs have established bilateral arrangements.
- f. Updates on PG Workspace(s) and OIML Web Site for RLMO RT;
  - The OIML Website and the PG Workspaces for the RT have been significantly upgraded by the BIML Staff this year!
- g. Follow-up interactions with EURAMET;
  - At the May 2022 Interim RT Meeting Dr. Jörn Stenger, Chairman of EURAMET, made a presentation welcoming collaboration with the RLMOs, singularly and/or as a group. At the annual RT meeting it was reported that GULFMET has explored this, and WELMEC has ongoing relations with EURAMET.

- h. E-learning progress/initiatives?;
  - A report was provided by Mr. Dunmill. Necessary computer hardware at the BIML is now in place, but software continues to be an issue.
  - Additionally, discussions on the possible incorporation of e-learning materials from APLMF on the OIML platform are continuing.
- i. How to better engage CEEMS countries/economies in the RLMO-RT?;
  - This continues to be a very important (but difficult) issue!
  - The CEEMS countries/economies are typically more engaged in their individual RLMO meetings.
  - Better addressing the needs of CEEMS countries for initial and subsequent verification of NAWIs (OIML R76) was also discussed.





#### **AFRIMETS**:

- The 15<sup>th</sup> AFRIMETS General Assembly took place virtually in July 2022, with the main focus being the continued self-sustainability of AFRIMETS.
- A Meeting of AFRIMETS Technical Committee Legal and a Workshop took place virtually before the AFRIMETS GA, also in July 2022.
- An AFRIMETS TC Legal Workshop was held on 13 July 2022. It focused on the regulation of smart electricity meters and was led by 3 distinguished international guests:
  - o Dr. Pavel Klenovský -Czech Metrology Institute, Brno
  - o Dr Juan Carlos Mateus Sánchez INMETRO, Brazil
  - o Ms Sowmya Ramakrishnan National Measurement Australia (NMIA), co-convener for the OIML TC 12/p 1.
- AFRIMETS TC LEGAL decided that this workshop will be followed—up by similar such workshops.



#### **COOMET:**

- The 33<sup>rd</sup> COOMET Committee online meeting was held last week, 25-27 October 2022.
- In 2022, a new COOMET Task Group on the "Issues of Digital Transformation in Metrology" was established.
- The COOMET TC 2 on "Legal Metrology" continued the translation of a number of OIML publications (including OIML D1:2020, D10, D30, D32, R75, and G14) and the Brochure UNIDO-OIML "Certification of measuring instruments" this year.
- In 2023, COOMET TC 2 plans for additional translations of OIML D11, D31, D 33, R125; and also plans to implement a project on "Development of rules for setting up reverification and recalibration intervals for measuring instruments used in the field of legal metrology."
- The 23<sup>rd</sup> COOMET TC 2 online meeting is scheduled to be held in December 2022.



### **GULFMET**:

- A GCC Certification Scheme is being developed that is based on the OIML-CS.
- Also, the GCC Common Metrology Law has been updated and put forward to the Ministerial Committee.
- GULFMET attended the CEEMS AG meeting in July 2022.
- GULFMET also participated in-person at the IMEKO Conference on 'Metrology and Digital Transformation' that was held in Berlin in September 2022.



## **SIM**:

- The SIM Web Page on Legal Metrology has been updated, and online meetings of the SIM LMWG are now being held every three months.
- A repository of the results of metrological verification of prepackaged products in the SIM countries is progressing using a template.
- Based on survey results, training courses in the areas of Energy Meters, Non-Automatic Weighing Instruments, Fuel Dispensers and Software have been identified as the key needs in the SIM countries.
- SIMEL (Colombia), RBMLQ-I (Brazil), SICOMET (Argentina) and, recently, INACAL (Peru) continue to work on Digitalization systems in their countries.
- Regulation of Smart Electricity Meters is now becoming a priority in some of the SIM countries.



### **WELMEC**:

- WELMEC approved 9 revised Guides, 2 new Guides and 1 'corresponding table' at the most recent Committee Meeting. Future Committee meetings will include short (10-minute) talks on hot issues in legal metrology through a "technical exchange." The next Committee Meeting will in May 2023, in Braunschweig.
- WELMEC is launching regular annual or biannual webinars to inform stakeholders about new developments in WELMEC activities. The first will be on November 23, 2022, on fitness-for-purpose of the European Directives in metrology.
- A new WELMEC Working Group has been established on Digital Transformation. Draft Terms of Reference have been established by the WELMEX Executive Board.
- An article on legal metrology has been published in the magazine *Nature Physics*. It is titled "The Metrology behind Trade" and was prepared by the WELMEC Chair and Executive Board members.

# **CEEMS AG Leadership Update**

- The CIML has appointed **Mr. Jaco Marneweck** as the CEEMS Advisory Group Chairperson for a 3-year term starting in January 2023. Mr. Marneweck (CIML member from South Africa) has served for several years as the AFRIMETS representative on both the CEEMS-AG and the RLMO-RT.
- The CIML has also appointed **Mr. Han Jianping** (from P.R. China) as the CEEMS-AG Vice-Chairperson for a 3-year term starting immediately.
- **Mr. Peter Mason** (from the UK) is the out-going CEEMS Advisory Group Chairperson. Mr. Mason was awarded an OIML Medal for his many years of service to OIML, including his 6-year term as the CIML President.
- As part of his report to the CIML, Mr. Mason strongly encouraged other CIML members to consider joining and contributing to the work of the CEEMS-AG.



# CEEMS-AG, Revision of OIML B 19

- In October 2022, the CIML approved the revision of B 19:2017 Terms of Reference for the Advisory Group on matters concerning Countries and Economies with Emerging Metrology Systems (CEEMS).
- Now having 6 years of experience since the formation of the CEEMS-AG, the revised B19 document provides for the following:
  - Additional functions of the AG such as promoting the OIML technical work, the OIML-CS, and new areas (e.g. digitalisation);
  - A more detailed procedure for nominating the AG Chairperson and Vice-Chairperson;
  - Revised Secretariat arrangements;
  - A more detailed process for co-opting experts (including the renewal of their terms);
  - Provisions for online meetings;
  - A procedure for appointing proxies from CIML volunteers and RLMO representatives; and
  - A provision for observers.



# Some CEEMS AG Activities

- New Guide. Development of a new publication entitled *Guide to the use of online technology for conducting CEEMS activities in a post-COVID world*; this should soon be published as an OIML Guide.
- **Digital Transformation in CEEMS**. The AG plans to conduct surveys on CEEMS priorities and provide assistance to the OIML DTG to develop proposals for guidance documents and for training.
- **OIML D1:2020** . National metrology systems Developing the institutional and legislative framework.
  - Work has started to encourage/promote the use of D 1 as widely as possible;
  - Collaboration with the BIPM to develop an e-Learning package and other materials on D 1.
- Additional Work.
  - Planning for OTC/OTE event on 'Prepackages and Statistic Control' planned for in Germany (3–7 July 2023):
  - Restarting of the CEEMS/p 1 project on the revision of D 14 *Training and qualification of legal metrology personnel*.
