16-18 NOVEMBER 2022 TBT COMMITTEE MEETING

ANNOTATED DRAFT AGENDA¹

The Committee on Technical Barriers to Trade (hereafter "the Committee") will hold its next regular meeting on 16-18 November 2022, starting at 10 a.m. on 16 November. The regular meeting will be preceded by Thematic Sessions on [Good Regulatory Practice](#) and on [Standards](#) (Standards development in Codex) on 15 November, starting at 10 a.m. An [ePing](#) Information Session will be held on Monday 14 November, starting at 3 p.m.

The following are the proposed items for the agenda:

1 ADOPTION OF THE AGENDA

The agenda is contained in [WTO/AIR/TBT/24](#) issued on 17 October 2022. Delegations are invited to indicate any items they may wish to raise under "Other Business" (Item 6).

2 IMPLEMENTATION AND ADMINISTRATION OF THE AGREEMENT

(A) Specific Trade Concerns (STCs)

Guidance to Members on the timeline for STCs and the use of eAgenda is provided in Annex 1 to this document. Annex 2 to this document contains a list of STCs which Members have communicated their intention to raise or support at the current meeting. In giving Members the floor, the Chairperson will follow the order set out in Annex 2 (first raising Members, followed by supporting Members). Members will be given an opportunity to update the Committee on any progress made, including resolutions, of STCs raised at previous meetings. It is noted that for the preparation of the minutes, the oral record of the meeting is the definitive reference, unless a specific request is made upon taking the floor that the full statement uploaded in eAgenda should be recorded in the minutes.

(B) Exchange of Experiences

(i) Transparency

Under this agenda sub-item, the Chair will provide a report on the Transparency Working Group meeting held on 13 October. The Chair will also seek to confirm the date of the Tenth Special Meeting on Procedures for Information Exchange, tentatively scheduled for 19 June 2023. The Secretariat will provide an update on the ePing Information Session held on 14 November. Members will also be given the opportunity to provide updates with respect to new or revised Article 15.2 Statements or raise any other matter relevant to transparency. Information about Members' Article 15.2 Statements, Enquiry Points and notifications is available through the [ePing SPS & TBT Platform](#).

(ii) Conformity Assessment Procedures

The Chair may propose to start the meeting with this agenda sub-item. Under this agenda sub-item, the Chair will provide a report on consultations and the informal meeting dedicated to conformity assessment procedures held on 13 October.

(iii) Good regulatory practice

Under this agenda sub-item, the Moderator will provide a report on the Thematic Session on Good Regulatory Practice held on 15 November.

(iv) Standards

Under this agenda sub-item, the Moderator will provide a report on the Thematic Session on Standards (standards development in Codex) held on 15 November.

(v) Covid-19

Members are invited to refer to [JOB/TBT/458](#) and [G/TBT/41](#), para. 8.4(A).

The Chairperson of the Council for Trade in Goods has requested the Chair of the TBT Committee (along with the other chairpersons of the subsidiary bodies) to prepare a brief report, under his own responsibility, on the WTO response to the pandemic. The report should describe the activities the TBT Committee has undertaken in the context of the pandemic over the past two years. It is aimed a better understanding how the Committee adjusted the focus of its work to address Pandemic-related issues. (draft forthcoming)

(vi) Functioning of the Committee (WTO reform)

The Chairperson of the Council for Trade in Goods has also requested the Chair of the TBT Committee (along with the other chairpersons of the subsidiary bodies) to prepare a brief report, under his own responsibility, on the "current functioning" of the committees – one of the issues Members would like to discuss under the umbrella of the WTO reform. This report should describe the concrete actions that the TBT Committee has adopted over the past years to improve its work. It is an opportunity for each Chairperson to present an overview of the reforms that have already been introduced. (draft forthcoming)

(C) Other Matters

- (i)** Under this sub-item, Delegations are invited to share views on the planning of the 2023 thematic sessions. Delegations wishing to raise any other matter relevant to the Implementation and Administration of the Agreement will be invited to do so under this sub-item.

Under this agenda item, Members will be invited to provide any information on their technical assistance activities. The Secretariat will provide an update on its technical assistance activities.

4 OBSERVERS

Observers are invited to provide, in advance of the meeting, updates to the Committee on relevant work, including on technical cooperation. Under this agenda item, Observers will be given an opportunity to highlight any key issues with respect to these updates.
