Marrakesh NFIDC Decision



Part of the Uruguay Round (UR) package

Establishes mechanisms to deal with potential negative effects of the UR Reform Programme on LDCs and NFIDCs

- Availability and adequacy of **international food aid** (international food aid architecture under the FAC)
- Financing of commercial imports
- ➤ Technical and financial assistance towards improved agricultural productivity and infrastructure
- Differential treatment of LDCs and NFIDCs in the disciplines on **export**

1 QUANTITY OF FOOD AID PROVIDED TO LEAST-DEVELOPED AND NET FOOD-IMPORTING DEVELOPING COUNTRIES

1.1. The Government of Japan (GOJ) grants funds to be used to purchase food. The total amount of the funds that GOJ granted was USD 17.7 million in calendar year 2022 (Refer to the Annex for details on shipments made during 2022).

2 INDICATION OF THE PROPORTION IN FULLY GRANT FORM OR APPROPRIATE CONCESSIONAL TERMS

2.1. All of the funds mentioned above were granted in fully grant form.

Specific flexibilities agreed for LDCs and NFIDCs under the Nairobi Decision



Export Subsidies

- Developed Members shall immediately eliminate their remaining scheduled export subsidy entitlements as of the date of adoption of this Decision.^{3,4}
- Developing country Members shall eliminate their export subsidy entitlements by the end of 2018.⁵
- 8. Developing country Members shall continue to benefit from the provisions of Article 9.4 of the Agreement on Agriculture until the end of 2023, i.e. five years after the end-date for elimination of all forms of export subsidies. Least developed countries and net food-importing developing countries listed in G/AG/5/Rev.10 shall continue to benefit from the provisions of Article 9.4 of the Agreement on Agriculture until the end of 2030.

Export Credits, Export Credit Guarantees or Insurance Programmes: longer repayment period

17. Notwithstanding the terms of paragraphs 15(a) and 16 above, least-developed and net food-importing developing countries listed in G/AG/5/Rev.10 shall be accorded differential and more favourable treatment comprising allowance for a repayment term in respect of them of between 36 and 54 months, for the acquisition of basic foodstuffs. Of Should one of these Members face exceptional circumstances which still preclude financing normal levels of commercial imports of basic foodstuffs and/or in accessing loans granted by multilateral and/or regional financial institutions within these timeframes, it shall have an extension of such a time-frame. The standard monitoring and surveillance provisions, as resulting from this Decision, shall apply to these cases.
