

Decision RC-12/1: Status of implementation

The Conference of the Parties,

Recalling decision RC-11/1 on the status of implementation,

Takes note of the information provided on the status of implementation of the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade;¹

- 1. *Encourages* Parties to continue to implement the relevant provisions of decisions RC-7/2, RC-9/1 and RC-11/1;
- 2. Requests the Secretariat to streamline information collection requests to Parties, taking into account the periodic questionnaire on the implementation of Articles 11 to 14 of the Convention and the work programme of the Compliance Committee of the Convention;
- 3. Requests the Secretariat, subject to the availability of resources, to continue to implement the provisions of decisions RC-7/2, RC-9/1 and RC-11/1 and to report on the implementation of the present decision to the Conference of the Parties at its thirteenth meeting.

Decision RC-12/2: Operation of the Chemical Review Committee

The Conference of the Parties

- 1. *Takes note* of the information provided in the reports of the Chemical Review Committee on the work of its nineteenth and twentieth meetings;¹
 - 2. *Confirms* the appointment of:
- (a) Giuseppe Granato (Italy) to replace Mirijam Seng (Belgium) for the remainder of her term, until 30 April 2028;
- (b) Amit Vashishtha (India) to replace Dinesh Runiwal for the remainder of his term, until 30 April 2028;
- (c) Tatiana Vásquez (Costa Rica) to replace Carlos Enrique Acevedo González (Guatemala) for the remainder of his term, until 30 April 2028;
- (d) Eline Lazdekalneas (Latvia) to replace Judite Dipane for the remainder of her term, until 30 April 2026;
- (e) Els Smit (Kingdom of the Netherlands) to replace Charles Bodar as of 1 September 2025 for the remainder of his term, until 30 April 2026;
- 3. Appoints the 15 designated experts listed in the annex to the present decision to serve as members of the Committee, with terms of office beginning on 1 May 2026 and ending on 30 April 2030;
- 4. Requests the Chemical Review Committee at its twenty-first meeting to identify an interim chair of the Committee for its twenty-second meeting and decides to consider the election of the Chair of the Committee at its thirteenth meeting;
- 5. Welcomes the activities conducted by the Secretariat for new members and requests the Secretariat to continue to implement training activities, for new and existing members, within the framework of the technical assistance plan, subject to the availability of resources, considering different delivery techniques and information channels, such as workshops and online training, and to report on the results of that work to the Conference of the Parties at its thirteenth meeting.

Decision RC-12/3: Listing of carbosulfan in Annex III to the Rotterdam Convention

The Conference of the Parties,

Recalling decision RC-8/6, in which the Conference of the Parties decided that all the requirements for listing in Annex III to the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade had been met,

Noting with appreciation the work of the Chemical Review Committee,

Having considered the recommendation of the Chemical Review Committee to make carbosulfan (CAS No. 55285-14-8) subject to the prior informed consent procedure and, accordingly, to list it in Annex III to the Rotterdam Convention as a pesticide,

1. Decides to amend Annex III to the Rotterdam Convention to list the following chemical:

Chemical	Relevant CAS number(s)	Category
Carbosulfan	55285-14-8	Pesticide

- 2. Also decides that this amendment shall enter into force for all Parties on 22 October 2025;
 - 3. Approves the decision guidance document on carbosulfan.¹

Decision RC-12/4: Listing of fenthion (ultra-low-volume formulations at or above 640 g active ingredient/L) in Annex III to the Rotterdam Convention

The Conference of the Parties,

Recalling decision RC-8/7, in which the Conference of the Parties decided that all the requirements for listing in Annex III to the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade had been met,

Noting with appreciation the work of the Chemical Review Committee,

Having considered the recommendation of the Chemical Review Committee to make fenthion (ultra-low-volume formulations at or above 640 g active ingredient/L) (CAS No. 55--38-9) subject to the prior informed consent procedure and, accordingly, to list it in Annex III to the Rotterdam Convention as a severely hazardous pesticide formulation,

1. Decides to amend Annex III to the Rotterdam Convention to list the following chemical:

Chemical	Relevant CAS number(s)	Category
Fenthion (ultra-low-volume formulations at or above 640 g active ingredient/L)	55-38-9	Severely hazardous pesticide formulation

- 2. Also decides that this amendment shall enter into force for all Parties on 22 October 2025;
- 3. Approves the decision guidance document on fenthion (ultra-low-volume formulations at or above 640 g active ingredient/L).¹

Decision RC-12/5: Enhancing the effectiveness of the Rotterdam Convention

The Conference of the Parties,

Recalling that the objective of the Rotterdam Convention is to promote shared responsibility and cooperative efforts among Parties in the international trade of certain hazardous chemicals in order to protect human health and the environment from potential harm and to contribute to their environmentally sound use, by facilitating information exchange about their characteristics, by providing for a national decision-making process on their import and export and by disseminating these decisions to Parties;

Taking note of decision RC-11/4, and recognizing that this decision continues efforts to enhance the effectiveness of the Rotterdam Convention as set out in decisions RC-7/5, RC-8/8, RC-9/6 and RC-10/10;

Noting that the Rotterdam Convention subjects chemicals listed in Annex III to the prior informed consent (PIC) procedure and does not prescribe bans;

- 1. Welcomes the activities agreed in the technical assistance plan for the implementation of the Basel, Rotterdam and Stockholm conventions for the period 2026–2029¹ related to risk evaluation and the preparation and transmission of notifications of final regulatory action;
- 2. *Invites* Parties and observers to transmit to the Secretariat information on resources and tools available to support governments and other stakeholders in implementing effective, best practice chemical management systems and their experiences in using such resources and tools;
- 3. *Requests* the Secretariat to compile the information transmitted by Parties and observers pursuant to paragraph 2 above and to make it available on the Convention website;
- 4. Requests the Secretariat, subject to the availability of resources, when providing support to the Chemical Review Committee and for the purpose of facilitating continuity of knowledge, expertise and coherence in the work of the Committee, to consider and, where possible, implement initiatives to provide additional training to current and incoming members, through online means;
- 5. Kindly invites the Joint Meeting on Pesticide Management (JMPM) of the Food and Agriculture Organization of the United Nations and the World Health Organization to discuss, as appropriate, the use of Annex III as a criterion for defining Highly Hazardous Pesticides (HHPs) under Criterion 6 of the Guidelines on Highly Hazardous Pesticides of the International Code of Conduct on Pesticide Management;
- 6. *Invites* Parties and observers to provide information to the Secretariat on provisions under the Rotterdam Convention that may be relevant for quality standards in the area of agriculture and food production;
- 7. Requests the Secretariat, subject to the availability of resources, to compile the information transmitted by Parties and observers pursuant to paragraph 6 above and make it available on the Convention website:
- 8. Takes note of the development of the Implementation Programme on developing integrated national chemicals and waste management systems and capacities at the national and regional levels under the Global Framework on Chemicals For a Planet Free of Harm from Chemicals and Waste;
- 9. Requests the Secretariat, subject to the availability of resources, to translate the Handbook of Working Procedures and Policy Guidance for the Chemical Review Committee into the six official languages of the United Nations;
- 10. Requests the Secretariat, in addition to the operational arrangements relating to language for the Chemical Review Committee and, subject to the availability of resources, for the conduct of meetings of the Chemical Review Committee, to provide simultaneous interpretation in the six official languages of the United Nations;
- 11. *Requests* the Secretariat to bring the present decision to the attention of the Food and Agriculture Organization of the United Nations and the World Health Organization.

Decision RC-12/6: Compliance Committee

The Conference of the Parties,

Welcoming the work of the Compliance Committee of the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade since the eleventh meeting of the Conference of the Parties to the Convention,

Templates for specific submissions by Parties

- 1. Encourages Parties to use the templates for specific submissions by Parties;¹
- 2. Requests the Secretariat to make the templates referred to in paragraph 1 above available to Parties on the Convention website;

Laws, regulations, policies, procedures and other measures to implement the Rotterdam Convention

- 3. *Recognizes* Parties that have adopted legislative and administrative measures to implement the Rotterdam Convention, and encourages all Parties to do so;
- 4. *Invites* Parties to continue to provide information to the Committee, using questions to collect information, including updates to information previously provided;
- 5. Decides to include in the technical assistance plan for the period 2026–2029 continued support to Parties for the development of, the establishment of and updates to legislative and administrative measures to implement the Rotterdam Convention, in particular to raise awareness and increase coordination among involved entities;
- 6. Requests the Secretariat to identify Parties' needs for assistance, assess the adequacy of tools and training activities to meet those needs, and any updates needed to existing tools and any new tools that should be developed in relation to legislative and administrative measures to implement the Rotterdam Convention:
- 7. Encourages the United Nations Environment Programme (including the secretariat of the Special Programme to support institutional strengthening at the national level for implementation of the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal, the Rotterdam Convention and the Stockholm Convention on Persistent Organic Pollutants, the Minamata Convention on Mercury, the Strategic Approach to International Chemicals Management and the Global Framework on Chemicals For a Planet Free of Harm from Chemicals and Waste), the Food and Agriculture Organization of the United Nations and other relevant entities, in their activities to support the technical assistance plan, to organize activities related to laws, regulations, policies, procedures and other measures to implement the Convention;

Notifications of final regulatory action

- 8. Requests the Secretariat to collect more information from Parties on the challenges faced with the submission of notifications of final regulatory action within 90 days of its taking effect;
- 9. Decides to continue to include in the technical assistance plan for the period 2026–2029 awareness-raising activities and exchanges of experiences and information on how to conduct risk evaluations;
- 10. Encourages the Food and Agriculture Organization of the United Nations, the United Nations Environment Programme and other relevant entities, in their activities to support the technical assistance plan, to continue their efforts to assist Parties in their actions to prepare and adopt final regulatory actions and to submit notifications of those final regulatory actions to the Secretariat;

Exports and imports of chemicals listed in Annex III

11. Decides to emphasize, in the technical assistance plan for the period 2026–2029, the importance of importing Parties' receiving support to transmit import responses, pursuant to Article 10 of the Convention, and of exporting Parties' ensuring that exporters comply with import responses pursuant to Article 11;

12. Encourages the Food and Agriculture Organization of the United Nations, the United Nations Environment Programme and other relevant entities, in their activities to support the technical assistance plan, to organize awareness-raising activities for importing Parties on the transmission of import responses in a timely manner and for exporting Parties on ensuring that exporters comply with import responses, particularly in regard to the communication of responses, and to provide Parties with opportunities to exchange lessons and good practices;

Export notifications

13. Decides to emphasize, in the technical assistance plan for the period 2026–2029, the importance of Parties' receiving support to raise awareness of the obligations under the Convention pertaining to the transmission and acknowledgement of receipt of export notifications, including training in completing the periodic questionnaire on Articles 11, 12, 13 and 14 of the Convention;

Programme of work for the biennium 2026-2027

- 14. *Approves* the programme of work of the Committee for the biennium 2026–2027 as set out in the annex to the present decision, and requests the Committee:
- (a) To consult Parties, in advance of the thirteenth meeting of the Conference of the Parties, on a draft programme of work for the biennium 2028–2029;
- (b) To report to the Conference of the Parties at its thirteenth meeting on the work it has carried out to fulfil its functions, in accordance with paragraph 26 of Annex VII to the Rotterdam Convention;
- 15. *Requests* the Secretariat to support the Committee, including, subject to the availability of resources, with the implementation of the activities in its programme of work;

II. Specific submissions regarding Party compliance

- 1. The Committee shall continue to accord priority to dealing with specific submissions regarding Party compliance received or initiated in accordance with paragraph 12 of Annex VII of the Rotterdam Convention.
- 2. The Committee shall continue to explore lessons from implementation and compliance bodies of other multilateral environmental agreements that could inform the work of the Committee pursuant to paragraph 13 of Annex VII to the Rotterdam Convention.



RC-12/7: Technical assistance¹

The Conference of the Parties,

Noting the activities undertaken by the partnerships established under the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal, the Committee Administering the Mechanism for Promoting Implementation and Compliance of the Basel Convention and the Compliance Committee of the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade in support of Parties' implementation of the conventions,²

- 1. Takes note of the report on the technical assistance needs of developing-country Parties and Parties with economies in transition for implementation of the Basel, Rotterdam and Stockholm conventions and the technical assistance available from developed-country Parties and others,³ as well as of the database summarizing the technical assistance needs;⁴
- 2. Encourages all relevant technical assistance providers to consider the information available in that database;
- 3. Requests the Secretariat to prepare the next report on the technical assistance needs of developing-country Parties and Parties with economies in transition, taking full account of the specific needs and special situations of the least developed countries and the Small Island Developing States in their actions, for implementation of the Basel, Rotterdam and Stockholm conventions and the technical assistance available from developed-country Parties and others for submission to the Conference of the Parties at its meeting in 2029;
- 4. *Takes note* of the report on the implementation of the technical assistance plan for the period 2024–2025,⁵ including capacity-building activities carried out and planned by the Secretariat for the implementation of the Basel, Rotterdam and Stockholm conventions;
- 5. Welcomes the technical assistance plan for the implementation of the Basel, Rotterdam and Stockholm conventions for the period 2026–2029;6
- 6. *Requests* the Secretariat to disseminate the plan by various means and to facilitate awareness of the plan by the relevant actors;
- 7. Encourages all relevant actors, including Parties, the regional centres under the Basel and Stockholm conventions, the United Nations Environment Programme, the Food and Agriculture Organization of the United Nations, the Global Environment Facility, the Special Programme to support institutional strengthening at the national level for implementation of the Basel, Rotterdam and Stockholm conventions, the Minamata Convention on Mercury, the Strategic Approach to International Chemicals Management and the Global Framework on Chemicals For a Planet Free of Harm from Chemicals and Waste, and participating organizations of the Inter-Organization Programme for the Sound Management of Chemicals to take the technical assistance plan for the implementation of the Basel, Rotterdam and Stockholm conventions for the period 2026–2029 into account in their activities, according to their mandates;
- 8. Encourages the relevant Parties, in line with Article 10 of the Basel Convention, Article 16 of the Rotterdam Convention and Article 12 of the Stockholm Convention, and invites others to voluntarily support the implementation of the technical assistance plan for the period 2026–2029;
 - 9. Requests the Secretariat, subject to the availability of resources, to:
- (a) Implement the technical assistance plan for the period 2026–2029 in accordance with the decisions adopted at the present meeting of the Conference of the Parties, including on the programmes of work and budgets of the conventions for the biennium 2026-2027, and in cooperation with relevant actors;

- (b) Maintain the database referred to in paragraph 1 above and ensure that it remains accessible through the websites of the conventions;
- 10. *Emphasizes* the key role of the regional centres, as described in the provisions of the Basel and Stockholm conventions, as well as the regional, subregional and country offices of the Food and Agriculture Organization of the United Nations, the United Nations Environment Programme and other participating organizations of the Inter-Organization Programme for the Sound Management of Chemicals, in delivering technical assistance upon request, particularly at the regional level, for implementation of the Basel, Rotterdam and Stockholm conventions and facilitating technology transfer respective to the relevant provisions of the Basel and Stockholm conventions.
- 11. Requests the Secretariat to report to the Conference of the Parties at its next meeting on the implementation of the present decision.

RC-12/8: Framework to develop a resource mobilization strategy for the African and Latin America and the Caribbean regions¹

The Conference of the Parties

- 1. *Requests* the Secretariat, subject to the availability of resources:
- (a) To develop a questionnaire on possible elements useful for developing guidance for a resource mobilization strategy from non-State actors for the African and Latin America and the Caribbean regions;
- (b) To compile and summarize the information received and make it available to Parties from the African and Latin America and the Caribbean regions;
- (c) To organize consultation sessions with Parties from the African and Latin America and the Caribbean regions to update and finalize potential guidance for resource mobilization from non-State actors for the African and Latin America and the Caribbean regions;
- (d) To prepare, based on the guidance referred to in sub-paragraph (c), a resource mobilization strategy from non-State actors for the African and Latin America and the Caribbean regions, for consideration by the Conference of the Parties at its next meeting;
- 2. *Invites* Parties from the African and Latin America and the Caribbean regions and other relevant stakeholders to provide information by 31 October 2025, including through the questionnaire referred to in paragraph 1(a).

RC-12/9: Cooperation and coordination with the Minamata Convention on Mercury¹

The Conference of the Parties,

Recognizing that the sharing of services within a stable framework will enhance cooperation and coordination based on experience and proximity and can foster the effective implementation of the Basel, Rotterdam and Stockholm conventions and the Minamata Convention without undermining the autonomy of the secretariats or the accountability of their executive heads,

- 1. Takes note of the joint report on cooperation and coordination between the secretariats of the Basel, Rotterdam and Stockholm conventions and of the Minamata Convention on Mercury,² and the outline of cooperation activities planned, including for the sharing and purchase of relevant services, between the two secretariats for the biennium 2026–2027;³
- 2. Reaffirms the importance of continued cooperation on programmatic synergies, of the use of the task force between the two secretariats and the United Nations Environment Programme Chemicals and Health Branch, and of the possibility for the Secretariat of the Basel, Rotterdam and Stockholm conventions to provide secretariat support to the Minamata Convention on a cost recovery basis, in accordance with the programme of work and budget of the conventions for each biennium;
 - 3. *Requests* the Executive Secretary:
- (a) To continue, with the secretariat of the Minamata Convention and under the overall steering of the task force, as appropriate, to cooperate on relevant administrative, programmatic, scientific and technical and technical assistance matters, in accordance with the programme of work and budget, and to explore ways to further strengthen cooperation and collaboration with the Minamata Convention;
- (b) To continue to implement shared services and the purchase of relevant services with the secretariat of the Minamata Convention on a cost recovery basis, as appropriate and in accordance with the programme of work and budget for each biennium;
- (c) To report on the implementation of the present decision, including on a stable framework for cooperation and for the sharing of services, and providing an outline of the cooperation activities planned under such a framework for the biennium 2026–2027, for the consideration of and, as necessary, further guidance by the Conference of the Parties at its next meeting.

RC-12/10: International cooperation and coordination with other organizations¹

The Conference of the Parties

- 1. Takes note of the report of the Secretariat on international cooperation and coordination for the period from 1 January 2023 to 31 December 2024² and the information provided by the secretariat of the intergovernmental negotiating committee to develop an international legally binding instrument on plastic pollution, including in the marine environment,³ the secretariat of the ad hoc open-ended working group on a science-policy panel to contribute further to the sound management of chemicals and waste and to prevent pollution⁴ and the secretariat of the Global Framework on Chemicals for a Planet Free of Harm from Chemicals and Waste,⁵ and in the report of the Executive Director of the United Nations Environment Programme on programmatic matters pertaining to the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal, the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade and the Stockholm Convention on Persistent Organic Pollutants;6
- 2. Expresses its appreciation to the international bodies with a mandate in areas of relevance to the Basel, Rotterdam and Stockholm conventions, including those listed in the report of the Secretariat on international cooperation and coordination for the period from 1 January 2023 to 31 December 2024, for their cooperation with the Secretariat, and invites them to continue to cooperate and coordinate, as appropriate, with the Secretariat;
- 3. Welcomes the cooperation with the secretariat of the intergovernmental negotiating committee to establish a legally binding instrument on plastic pollution, including in the marine environment, in accordance with United Nations Environment Assembly resolution 5/14, entitled "End plastic pollution: towards an international legally binding instrument", and requests the Executive Secretary to continue to cooperate and coordinate closely with the Executive Director of the United Nations Environment Programme in the context of the mandate of the intergovernmental negotiating committee and to participate in its work on issues relevant to the Basel, Rotterdam and Stockholm conventions;
- 4. Reiterates its invitation to Parties participating in the intergovernmental negotiating committee to ensure that the international legally binding instrument is fully coherent with and complementary to the Basel, Rotterdam and Stockholm conventions, that it avoids duplication of the actions set out in the relevant provisions thereof and that it promotes cooperation and coordination with those conventions, and to ensure that the expertise of the Secretariat and the Parties and the experience gained in implementing the conventions is fully shared in order to help the intergovernmental negotiating committee in its deliberations, and also reiterates its encouragement to the regional centres of the Basel and Stockholm conventions to participate in the work of the intergovernmental negotiating committee and to share their expertise;
- 5. Acknowledges the presence and participation of the Secretariat in the process of the intergovernmental negotiating committee, including regional groups and intersessional working groups, and the activities conducted by the Secretariat in its cooperation with the intergovernmental negotiating committee, and requests the Secretariat to continue to provide the intergovernmental negotiating committee with information on the Basel, Rotterdam and Stockholm conventions relevant to its work;
- 6. Welcomes the cooperation between the Secretariat and the United Nations Environment Programme in the context of the ad hoc open-ended working group, in accordance with Environment Assembly resolution 5/8 on a science-policy panel to contribute further to the sound management of chemicals and waste and to prevent pollution, and requests the Executive Secretary to continue to contribute to the preparation of proposals for the science-policy panel and cooperate closely with the

Executive Director of the United Nations Environment Programme, and, once it has been established, the appropriate bodies of the science-policy panel;

- 7. Reiterates its invitation to Parties participating in the ad hoc open-ended working group to promote coordination and cooperation, as well as complementarity between and non-duplication of the work of the science-policy panel and that of the conventions, and to ensure that there is close cooperation with science-policy bodies under the conventions, as appropriate, and that the extensive experience of science-based promotion of the sound management of chemicals and waste is made available to the ad hoc open-ended working group;
- 8. Welcomes the relevant resolutions adopted by the Environment Assembly at its sixth session, including resolution 6/9 on sound management of chemicals and waste,⁷ resolution 6/11 on highly hazardous pesticides,⁸ resolution 6/5 on environmental aspects of minerals and metals,⁹ resolution 6/4 on promoting synergies, cooperation or collaboration for national implementation of multilateral environmental agreements and other relevant environmental instruments,¹⁰ resolution 6/6 on fostering national action to address global environmental challenges through increased cooperation between the Environment Assembly, the United Nations Environment Programme and the multilateral environmental agreements¹¹ and resolution 6/3 on enhancing the role and viability of regional forums of ministers of the environment and United Nations Environment Programme regional offices in achieving multilateral cooperation in tackling environmental challenges;¹²
- 9. Also welcomes the work facilitated by the United Nations Environment Programme under the Bern process, including the outcomes of its third conference, and invites the Secretariat, subject to the availability of resources, to continue its engagement, in collaboration with other multilateral environmental agreements, in the process;
- 10. Encourages Parties to engage in the Bern process and actively promote cooperation and policy coherence among multilateral environmental agreements at the national level, taking into account national circumstances, needs and priorities through, as appropriate, a whole-of-government and whole-of-society approach;
- 11. Reiterates its request to the Executive Secretary to cooperate with the Executive Director of the United Nations Environment Programme in fostering the implementation of activities described in Environment Assembly resolutions that are relevant to the Basel, Rotterdam and Stockholm conventions;
- 12. *Invites* the Executive Director of the United Nations Environment Programme, when carrying out activities of relevance to the Basel, Rotterdam and Stockholm conventions, to cooperate with the Secretariat and to take into account relevant decisions of the conferences of the Parties and the programmes of work of the conventions;
- 13. Welcomes the programmatic cooperation between the Secretariat, the United Nations Environment Programme and the Food and Agriculture Organization of the United Nations on programmatic matters of mutual interest;
 - 14. Requests the Secretariat to continue such programmatic cooperation efforts;
- 15. Reiterates the requests contained in paragraphs 18 and 19 of decisions BC-15/25, RC-10/14 and SC-10/21 for the Secretariat to continue to cooperate with relevant organizations with regard to the contributions of the Basel, Rotterdam and Stockholm conventions to the achievement of the Sustainable Development Goals;
- 16. *Welcomes* the adoption of the Global Framework on Chemicals, takes note of the report of the Secretariat on how the Basel, Rotterdam and Stockholm conventions might contribute to the implementation of the Framework, ¹³ and requests the Secretariat, subject to the availability of resources, to implement the proposed activities to contribute towards the implementation of the Framework; ¹⁴

- 17. *Takes note* of the exploratory study on interlinkages between the Montreal Protocol on Substances that Deplete the Ozone Layer and the Basel, Rotterdam and Stockholm conventions;¹⁵
- 18. Also takes note of the report on how the Basel, Rotterdam and Stockholm conventions might contribute to the implementation of the 2030 targets and 2050 goals of the Kunming-Montreal Global Biodiversity Framework, ¹⁶ and requests the Secretariat to cooperate with the Convention on Biological Diversity secretariat and other appropriate bodies in the further work on the monitoring framework for the Global Biodiversity Framework, in particular with regard to indicators under target 7 on pollution; ¹⁷
- 19. Further takes note of the report on the status of work by the World Customs Organization on the Harmonized Commodity Description and Coding System related to the chemicals listed in Annex III to the Rotterdam Convention, 18 and reminds Parties of the obligation under the Rotterdam Convention to require that, whenever a code has been assigned to a chemical, the shipping document bear the code for that chemical when exported; 19
 - 20. Requests the Secretariat to:²⁰
- (a) Propose to the World Customs Organization amendments to the Harmonized System to specifically identify chemicals that are included in the annexes to the Stockholm Convention, for which specific codes do not already exist;
- (b) Invite the World Customs Organization to develop recommendations on interim changes that can be made to national nomenclatures to facilitate the use of newly approved customs codes:
- 21. *Welcomes* the entry into force of the Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships, 2009;²¹
- 22. Takes note of the information provided by the secretariat of the International Maritime Organization,²² including the provisional guidance on the implementation of the Hong Kong and Basel conventions with respect to the transboundary movement of ships intended for recycling,²³ approved by the Marine Environment Protection Committee of the International Maritime Organization at its eighty-second session;
- 23. *Invites* Parties and observers to submit to the Secretariat, by 15 November 2025, comments on the provisional guidance referred to in paragraph 22 above and any other additional comments from the perspective of the Basel Convention on the implementation of the Hong Kong and Basel conventions with respect to the transboundary movement of ships intended for recycling;
- 24. Requests the Secretariat, subject to the availability of resources, to reflect the comments referred to in paragraph 23 above and to submit them for consideration by the Open-ended Working Group of the Basel Convention at its fifteenth meeting, so as to prepare a draft decision with recommendations to the Conference of the Parties to the Basel Convention at its eighteenth meeting;
- 25. *Also requests* the Secretariat to transmit the present decision to the Marine Environment Protection Committee;
 - 26. Welcomes the adoption by the Group of 20 of the Rio de Janeiro Leaders' Declaration;²⁴
- 27. Requests the Executive Secretary to initiate communications with the secretariats of the United Nations Environment Programme, the Bamako Convention on the Ban of the Import into Africa and the Control of Transboundary Movement and Management of Hazardous Wastes within Africa, and the Waigani Convention to Ban the Importation into Forum Island Countries of Hazardous

- (b) To continue its collaboration with the secretariat of the Minamata Convention on Mercury to exchange information and share experiences and best practices regarding the use of existing clearing-house mechanism systems;
- 5. *Invites* Parties and observers to participate, as appropriate, in the implementation and further development of the clearing-house mechanism strategy and in relevant activities of the workplan for the biennium 2026–2027, in accordance with the present decision;
- 6. Requests the Secretariat to keep the strategy under regular review in order to take into account lessons learned and relevant developments regarding the international agenda on the sound management of chemicals and waste.

The Conference of the Parties,

Noting decision BC-17/17 on national legislation, notifications, enforcement of the Basel Convention and efforts to combat illegal traffic,

Preventing and combating illegal trade in hazardous chemicals covered by the Rotterdam and Stockholm conventions²

- 1. Reiterates its encouragement to Parties to voluntarily provide information about cases of international trade in hazardous chemicals occurring in contravention of the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade and the Stockholm Convention on Persistent Organic Pollutants, using the forms adopted by the conferences of the Parties to the Rotterdam and Stockholm conventions at their tenth meetings;³
- 2. Reiterates its invitation to Parties to continue to provide best practices for preventing and combating illegal trade in hazardous chemicals and wastes covered by the Rotterdam and Stockholm conventions and to continue to share information through the Secretariat on actions taken to implement and enforce the trade control measures, as well as on challenges Parties may be facing;
- 3. *Takes note* of the case studies on action taken by Parties to implement and enforce the trade control measures of the Rotterdam and Stockholm conventions;⁴
- 4. *Encourages* enforcement entities to include the illegal trade in hazardous chemicals covered by Rotterdam and Stockholm conventions within the scope of their planned operations;
 - 5. *Requests* the Secretariat:
- (a) To continue collecting information on best practices for preventing and combating illegal trade in hazardous chemicals and wastes covered by the Rotterdam and Stockholm conventions and on cases of illegal trade in hazardous chemicals occurring in contravention of the conventions submitted by Parties on a voluntary basis and to make such information available on the website of the conventions;
- (b) To continue to develop, subject to the availability of resources, case studies on action taken by Parties to implement and enforce the trade control measures of the Rotterdam and Stockholm conventions;
- (c) To continue to provide Parties, upon request, with assistance in identifying cases of illegal trade in hazardous chemicals;

- (a) To continue to provide advice and, subject to the availability of resources, conduct awareness-raising and technical assistance activities to strengthen the capacity of Parties, including enforcement entities, to prevent and combat illegal trade in hazardous chemicals and wastes covered by the Rotterdam and Stockholm conventions, including actions contained in the workplan referred to in paragraph 8 above;
- (b) To further explore areas and opportunities for collaboration to prevent and combat the illegal trade in pesticides covered by the Rotterdam and Stockholm conventions with relevant international and regional organizations and entities, including with a view to identifying the extent of the illegal trade in chemicals covered by the Rotterdam and Stockholm conventions;
- (c) To report to the Conference of the Parties at its next meeting on the implementation of the present decision.

The Conference of the Parties

- 1. Takes note of the information on the workshops and other actions to implement the road map for further engaging Parties and other stakeholders in an informed dialogue for enhanced science-based action in the implementation of the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal, the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade and the Stockholm Convention on Persistent Organic Pollutants;²

RC-12/14: Venue and dates of the next meetings of the conferences of the Parties to the Basel, Rotterdam and Stockholm conventions¹

The Conference of the Parties

- 1. Takes note with appreciation of the offer by the Government of the Panama to host the next meetings of the conferences of the Parties to the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal, the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade and the Stockholm Convention on Persistent Organic Pollutants in 2027 in Panama;
- 2. Decides to convene the next meetings of the conferences of the Parties to the Basel, Rotterdam and Stockholm conventions back to back, from 19 to 30 April 2027, in Panama City, Panama, subject to the satisfactory conclusion of a host country agreement between the Government of Panama and the Secretariat on arrangements for the meetings of the conferences of the Parties;
- 3. *Also decides* that the meetings will include joint sessions, where appropriate, on joint issues;
 - 4. Further decides that the meetings will not include a high-level segment;
- 5. Requests the Executive Secretary to enter into consultations with the Government of Panama with a view to agreeing on satisfactory arrangements and concluding a host country agreement for hosting the meetings as referred to in paragraphs 2 to 4 above;
- 6. Requests the Executive Secretary, in order to assist Parties in preparing for the back-to-back meetings, to support, subject to the availability of resources, regional meetings, held in coordination with other regional meetings, to assist regional preparatory processes;
- 7. *Invites* Parties to submit, if possible by 8 January 2027, offers to host the 2029 meetings of the conferences of the Parties, for consideration during the meetings of the conferences of the Parties to be held in 2027.

Decision RC-12/15: Programme of work and budget for the biennium 2026–2027 of the Rotterdam Convention

The Conference of the Parties,

Recalling decision RC-11/15 on the programme of work and budget for the Rotterdam Convention for the biennium 2024–2025,

Taking note of the financial reports for 2022 and 2023 from the general trust fund for the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade (Rotterdam Convention general trust fund),¹

Taking note also of the report of the Executive Director of the United Nations Environment Programme to the respective conferences of the Parties to the Basel, Rotterdam and Stockholm conventions on the implementation of the memorandums of understanding² and of the report of the Director General of the Food and Agriculture Organization of the United Nations to the Conference of the Parties to the Rotterdam Convention,³

Rotterdam Convention general trust fund

- 1. Approves the programme budget for the Rotterdam Convention for the biennium 2026–2027 of 4,479,921 United States dollars for 2026 and 4,479,921 United States dollars for 2027, for the purposes set out in table 1 of the present decision;
- 2. *Authorizes* the executive secretaries of the Rotterdam Convention to make commitments up to the amount of the approved operational budget, drawing on available cash resources;
- 3. *Decides* to maintain the working capital reserve at the level of 15 per cent of the annual average of the biennial operational budgets for the biennium 2026–2027;
- 4. *Invites* the governing bodies of the United Nations Environment Programme and the Food and Agriculture Organization of the United Nations to continue their financial and other support for the operation of the Rotterdam Convention and its Secretariat in the biennium 2026–2027;
- 5. *Welcomes* the continued annual contributions by Italy and Switzerland, the host countries of the Secretariat, of 600,000 euros each to the Secretariat to offset planned expenditures;
- 6. Notes that, of Switzerland's annual host country contribution of 600,000 euros, 50 per cent will be apportioned to the Rotterdam Convention general trust fund and 50 per cent to the special voluntary trust fund for the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade (Rotterdam Convention special trust fund for voluntary contributions) for 2026–2027;
- 7. Adopts the indicative scale of assessments for the apportionment of expenses for the biennium 2026–2027 set out in table 2 of the present decision and authorizes the executive secretaries, consistent with the Financial Regulations and Rules of the United Nations, to adjust the scale to include all Parties for which the Convention enters into force before 1 January 2026 for 2026 and before 1 January 2027 for 2027;
- 8. Recalls that contributions to the Rotterdam Convention general trust fund are expected by 1 January of the year for which those contributions have been budgeted, urges Parties to pay their contributions promptly, encourages Parties in a position to do so to pay their contributions by 15 October 2025 for the calendar year 2026 and by 15 October 2026 for the calendar year 2027, and requests the Secretariat to notify Parties of the amounts of their contributions as early as possible in the year preceding the year in which they are due;
- 9. Reiterates its ongoing concern that a number of Parties have not paid their contributions to the Rotterdam Convention general trust fund for 2024 and prior years, contrary to the provisions of paragraph 3 (a) of rule 5 of the financial rules of the Rotterdam Convention, and urges Parties to pay their outstanding contributions in full as soon as possible;

- 10. Requests the Secretariat to work directly with the permanent missions, ministries of foreign affairs and focal points of the Parties in that situation so that they fully pay their arrears and assessed contributions as soon as possible, and to present at regional meetings information on the current situation regarding arrears and their consequences;
- 11. Requests the Executive Director of the United Nations Environment Programme to continue to work closely with the Executive Secretary of the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal, the Rotterdam Convention and the Stockholm Convention on Persistent Organic Pollutants to improve the timely communication of information on the payment of contributions, including arrears;
- 12. Recalls the provisions of paragraph 3 (e) of rule 5 of the financial rules with regard to contributions due from 1 January 2005 onwards and paragraph 11 of decision RC-11/15, and decides to continue the practice that no representative of any Party whose contributions are in arrears for two or more years shall be eligible to become a member of the Bureau of the Conference of the Parties or a member of any subsidiary body of the Conference of the Parties, provided, however, that this shall not apply to Parties that are least developed countries or small island developing States or to any Party that has agreed on and is respecting a schedule of payments implemented in accordance with the financial rules;
- 13. Also recalls the provisions of paragraph 12 of decision RC-11/15, and decides that no representative of any Party whose contributions are in arrears for four or more years and that has not agreed on or is not respecting a schedule of payments implemented in accordance with paragraph 3 (d) of rule 5 of the financial rules shall be eligible to receive financial support for attendance at intersessional workshops or other informal meetings, as arrears that have been outstanding for more than four years must be treated as 100 per cent doubtful debts under the International Public Sector Accounting Standards;
- 14. *Notes* the efforts of the executive secretaries and the President of the Conference of the Parties, who through a jointly signed letter invited the ministers for foreign affairs of Parties with contributions in arrears to take timely action to rectify those arrears, requests that this practice continue, and thanks those Parties that have responded in a positive manner by paying their outstanding contributions;
- 15. Adopts the staffing table of the Secretariat for the biennium 2026–2027 used for costing purposes to set the overall budget, which is set out in table 3 of the present decision;
- 16. Authorizes the executive secretaries to continue to determine the staffing levels, numbers and structure of the Secretariat in a flexible manner, provided that positions remain at the same level or become lower, that the executive secretaries remain within the overall cost for the staff numbers set out in table 3 of the present decision for the biennium 2026–2027, and that the staffing does not cause any additional budget obligations to be incurred beyond that biennium;
- 17. Authorizes, on an exceptional basis, the executive secretaries, as a last resort, to draw additional funds, not exceeding 188,506 United States dollars, from the net balance of the general trust funds of the Basel, Rotterdam and Stockholm conventions to cover any shortfall in the approved staffing envelope for the biennium 2026–2027, should the annual increase applied to real staff costs and used to determine the staffing envelope not be adequate, provided that the overall balance of the trust funds is not reduced below the working capital reserve, and requests the executive secretaries to report thereon to the Conference of the Parties at its thirteenth meeting, as appropriate;
- 18. Requests the executive secretaries to report to the Conference of the Parties at its thirteenth meeting on the level of positions filled against the approved staffing table;

Rotterdam Convention special trust fund for voluntary contributions

- 19. *Takes note* of the funding estimates of 2,664,257 United States dollars for 2026 and 2,664,257 United States dollars for 2027, in table 1 of the present decision, for activities under the Convention to be financed from the Special Voluntary Trust Fund for the Rotterdam Convention (Rotterdam Convention special trust fund for voluntary contributions);
- 20. Notes that the requirements for the Rotterdam Convention special trust fund for voluntary contributions presented in the budget represent the Secretariat's best efforts to be realistic and reflect priorities agreed on by all Parties, and urges Parties, and invites non-Parties and others, to

make voluntary contributions to the Rotterdam Convention special trust fund for voluntary contributions:

- 21. *Notes* the importance of having funding available in the Rotterdam Convention special trust fund for voluntary contributions for the participation of developing-country Parties, in particular least developed countries and small island developing States, and of Parties with economies in transition in meetings under the Convention;
- 22. Reiterates that it looks forward to the outcomes of the work of the United Nations Environment Programme task force established to conduct an overall review of the current methodology for calculating and allocating programme support costs, which, once available, may be considered by the Conference of the Parties;
- 23. *Urges* Parties, and invites others in a position to do so, to contribute, as a matter of urgency and as early as feasible, to the Rotterdam Convention special trust fund for voluntary contributions with a view to ensuring the full and effective participation of developing-country Parties, in particular least developed countries and small island developing States, and of Parties with economies in transition in the meetings of the Conference of the Parties;
- 24. *Invites* Switzerland to include in its contribution to the Rotterdam Convention special trust fund for voluntary contributions, referred to in paragraph 6 above, support for, among other things, the participation of developing-country Parties, in particular least developed countries and small island developing States, and of Parties with economies in transition in meetings under the Convention and in joint activities under the Basel, Rotterdam and Stockholm conventions;

Preparations for the next biennium

- 25. *Notes* the efforts since 2012 to enhance efficiency in the use of financial and human resources in the Secretariat and encourages the executive secretaries to continue such efforts in the future work of the Secretariat;
- 26. Requests the executive secretaries to prepare a budget for the biennium 2028–2029 for consideration by the Conference of the Parties at its thirteenth meeting, explaining the key principles, assumptions and programmatic strategy on which the budget is based and presenting expenditures for the biennium 2026–2027 in a programmatic format;
- 27. Also requests the executive secretaries to determine the staffing levels, numbers and structure of the Secretariat in a staffing table and reflect the total actual costs in the budget of the Convention for the biennium 2028–2029;
- 28. *Notes* the need to facilitate priority-setting by providing Parties with timely information on the financial consequences of various options and, to that end, requests the executive secretaries to include in the proposed operational budget for the biennium 2028–2029 two funding scenarios that take into account any efficiencies identified as a result of paragraph 25 above and are based on:
- (a) The executive secretaries' assessment of the required changes in the operational budget, which should not exceed a 5 per cent increase over the 2026–2027 level in nominal terms, to finance all proposals before the Conference of the Parties that have budgetary implications;
 - (b) Maintaining the operational budget at the 2026–2027 level in nominal terms;
- 29. Requests the Secretariat, in collaboration with the Food and Agriculture Organization of the United Nations, to report to the Conference of the Parties which activities were financed from the Food and Agriculture Organization of the United Nations contribution in the implementation of the programme of work for the biennium 2026–2027, and to identify which activities are going to be implemented, funded or co-funded from that contribution in the programme of work and budget for the biennium 2028–2029;
- 30. Requests the executive secretaries, at the thirteenth meeting of the Conference of the Parties, to provide, where relevant, cost estimates for actions with budgetary implications that are not foreseen in the draft programme of work but are included in proposed draft decisions, before the adoption of those decisions by the Conference of the Parties;
- 31. Also requests the executive secretaries to allocate resources to fund the travel of participants from developing-country Parties and Parties with economies in transition on the basis of

the country classification lists developed by the United Nations Secretariat,⁴ in observance of paragraph 3 (b) of rule 4 of the financial rules;

32. *Stresses* the need to ensure that the proposal for the requirement for the Rotterdam Convention special trust fund for voluntary contributions for the biennium 2028–2029 presented in the budget is realistic and represents the agreed priorities of all Parties so as to encourage voluntary contributions from donors.
